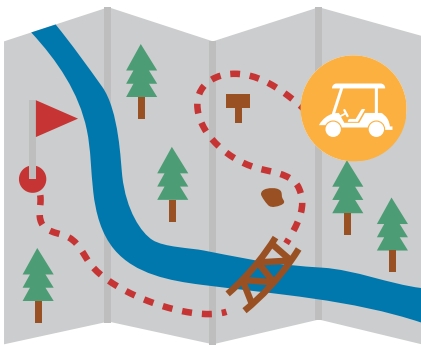


Cancellation/Refund Policy: Policies regarding refunding of registration fees for the SDAHO Convention are:

Recognizing addiction as a chronic disease fundamentally shifts how we approach treatment, emphasizing the importance of long-term management and comprehensive care. Innovative solutions for South Dakota's healthcare landscape include embracing harm reduction, encouraging low-threshold addiction treatment, utilizing telemedicine platforms, and prioritizing an integrated community response.

Psychotropic Reduction: An Interdisciplinary Approach | Amy Siple, APRN, FNP, GS-C | CE: LNHA, SW

The off-label use of psychotropics to manage the neuropsychiatric symptoms associated with dementia is historically widespread. This is despite evidence showing limited benefits and high mortality risk. This interactive presentation is designed to explore a root cause analysis of these neuropsychiatric symptoms using an interdisciplinary approach. A review of recently approved antipsychotics for dementia-related agitation will be discussed.

EHR on FHIR: Results From First FHIR-Powered Prior Authorization | Heidi Kriz | Presented by SDHIMSS | *Certificate of Attendance*

As healthcare spending grows uncontrollably, prior authorization is crucial for cost containment and ensuring the medical necessity of procedures and treatments. A 2019 JAMA study found that about 25% of healthcare spending may be wasteful, and 88% of physicians report a high administrative burden for authorization requests. This session will highlight how a payer and provider partnered to launch a new data exchange framework to streamline prior authorization. Implemented in October 2022, this FHIR (Fast Healthcare Interoperability Resources)-powered system allows providers to complete requests within their native HER (Electronic Health Record), automating the process and reducing turnaround time from days to seconds. The payer and provider will share their first-year results, lessons learned, and how this workflow can be applied to other providers and payers.

A Post-Acute Referral Center (PARC) was established as a centralized hub to coordinate various post-acute care services, facilitating safe discharge plans. In this session, you will learn key strategies for implementing a Post-Acute Referral Center in multiple healthcare settings, leveraging team expertise, improving care coordination timeliness, and enabling staff to work at the top of their scope.
