SF2435 – Education Appropriations Bill

- Establishes restrictions related to Diversity, Equity, and Inclusion Efforts of Higher Education governed by the BOR
- Sec. 32, 261J.2 Diversity, Equity, and Inclusion office prohibited.
- Sec. 33, 261J.3 Restrictions on use of monies.
- Division IX, Section 31. 1e states:

Any effort to promote, as the official position of the public institution of higher education, a particular, widely contested opinion referencing unconscious or implicit bias, cultural appropriation, allyship, transgender ideology, microaggressions, antiracism, systemic oppression, social justice, etc.

While many of the provisions are similar to those in the BoR directives, there are some diff grences in the language. This law takes effect **July 1, 2025**. Additional clarity around the interpretation and application of the law will continue throughout the next 14 months.

Senate file 2435 overview

DEI is defined by SF 2435 as any effort to:

- Promote or promulgate trainings, programming, or activities designed or implemented with reference to race, color, ethnicity, gender identity or sexual orientation.
- Promote, as the official position of the university, a particular, widely contested opinion
 referencing unconscious or implicit bias, cultural appropriation, allyship, transgender
 ideology, microaggressions, group marginalization, antiracism, systemic oppression, social
 justice, intersectionality, neo-pronouns, heteronormativity, disparate impact, gender theory,
 racial privilege, sexual privilege, or any related formulation of these concepts.
- 3. Robert Kennedy Jr if confirmed to the Department of Health and Human Services will lead one of the largest federal departments responsible not only for medications and vaccines but also for agencies that fund medical research, provide public health insurance to millions of Americans, and oversee the nation's response to public health emergencies like pandemics.

Clinical Practice questions

Your question: What are ASPAN's standards regarding postop phone calls? Is it necessary to make a second attempt if no answer on the first attempt? Is it required that specifically PACU RNs complete the postop phone calls?

Answer: The 2023-2024 Perianesthesia Nursing Standards, Practice Recommendations and Interpretive Statements does not specifically address those questions. The Practice Recommendation - Components of Assessments and Management for the Perianesthesia Patient Practice Recommendation B: Post Anesthesia Phases of Care states. "Post discharge patient follow-up is required. The follow-up may be accomplished in various ways. Although The Joint Commission (TJC) and Centers for Medicare & Medicaid Services (CMS) do not require a postoperative phone call, other regulatory agencies may. TJC requires that reassessment is done on all patients at intervals determined by the facility" (P. 62). Studies have shown that follow ups and reassessments improve patient satisfaction and compliance with their treatment plans, identify any potential complications, and decrease unnecessary ED visits. Follow ups and reassessments can be in many forms, a phone call, a mailed survey, or any forms that the health care organizations prefer. The Joint Commission does require the health care organization to have a policy in place to clearly define how the follow-ups and reassessments are being done (Godden, 2010). Whether a second attempt needs to be made or only RNs can make the postop phone calls really depend on what your institutional policy says. I would recommend reaching out to your department manager or locating your institutional policy for further clarification.

Your question: What are ASPAN's standards for the PACU call team consisting of 2 RN's preoping a pt. & simultaneously recovering a Ph 1 pt. direct from the OR?

Answer: In the 2023,2024 Perianesthesia Nursing Standards, Practice Recommendations and Interpretive Statements III/ Environment of Care p. 37, it states "Perianesthesia patients may be in the same physical space as patients recovering from anesthesia or sedation as staffing and room design permits; however, they should be cohorted, and separated as far away as physically possible from Phase 1 patients. Efforts should be made to provide privacy for the patient and family so that patients waiting for their procedure not hear activity related to patients emerging from anesthesia or sedations. It is also desirable to have a separate healthcare team; that is, a preoperative nurse is not also caring for a post anesthesia patient. Also, keep in mind, that Practice Recommendation Patient Classification/Staffing Recommendations states on p. 49 that Two registered nurses, one of whom is a perianesthesia nurse competent in Phase 1 postanesthesia nursing, are in the same room/unit where the patient is receiving Phase 1 care. The Phase 1 registered nurse must have immediate access and direct line of sight when providing patient care. The second nurse should be able to directly hear a call for assistance and be immediately available to assist.

These staffing recommendations should be maintained during "on call" situations. In my former hospital, we staffed a Holding Room nurse in our Phase 1 PACU on Saturday and Sunday from 7am-5pm that would pre-op in-patients and patients coming from the ER requiring surgery. Our Phase 1 PACU had a partial wall that divided the Phase 1 PACU from the Holding Room. When we were called into the hospital to recover a patient in the Phase 1 PACU, our Holding Room nurse would become our second nurse in the room to meet the ASPAN Standard of having two nurses in the same room when recovering a Phase 1 PACU patient. I hope that this information will assist you in promoting safe patient care and achieving evidence-based practice in your facility.

Changes to CPAN/CAPA

CERTIFICATION

To read more about these changes and how they may affect your 2024 recertification, please visit the ABPANC website here.

Highlights of the changes include:

- All contact hours must be perianesthesia related
- The number of required contact hours will be reduced from 90 hours to 70 hours
- The direct versus indirect care categories for contact hours will be eliminated
- The recertification reinstatement period will be extended from 15 days to 90 days
- Recertification by exam option will be discontinued by 2027

Please note the new Recertification Handbook reflecting these changes will not be available until after the close of the fall 2023 recertification window.
