#### Federal Updates:

Senate version of Tax & Budget Bill (different version from Big Beautiful Bill)

- > Senate's self-imposed deadline July 4th
- > Significant tax cuts & spending provisions
  - o Boost to the state & local tax (SALT) deduction cap
  - o Changes to tax brackets exemptions for CA & NY
  - o Deduction for tips & overtime pay

- o Provisions related to border security, welfare, & infrastructure
- o Higher debt ceiling
- o **Reauthorization of Title VIII Funding:** The Act proposes reauthorizing funding for Title VIII Nursing Workforce Development Programs from FY2026 through FY2030. This reauthorization aims to address nurse shortages and improve the quality of healthcare, especially in underserved areas, representing an investment in the nursing profession and the nation's health.
- o **Medicaid** Significant changes. Reduces federal funding for Medicaid by \$1 trillion over ten years. ANA initiative share your concerns on what implications this has in your facilities.
  - Cuts to Medicaid would result in hospital and clinic closures, especially in rural areas, and would force nurses to shoulder even heavier workloads, leading to burnout, attrition, and ultimately, worse patient outcomes."
