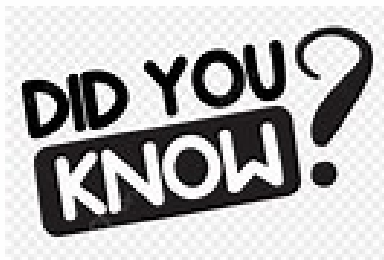

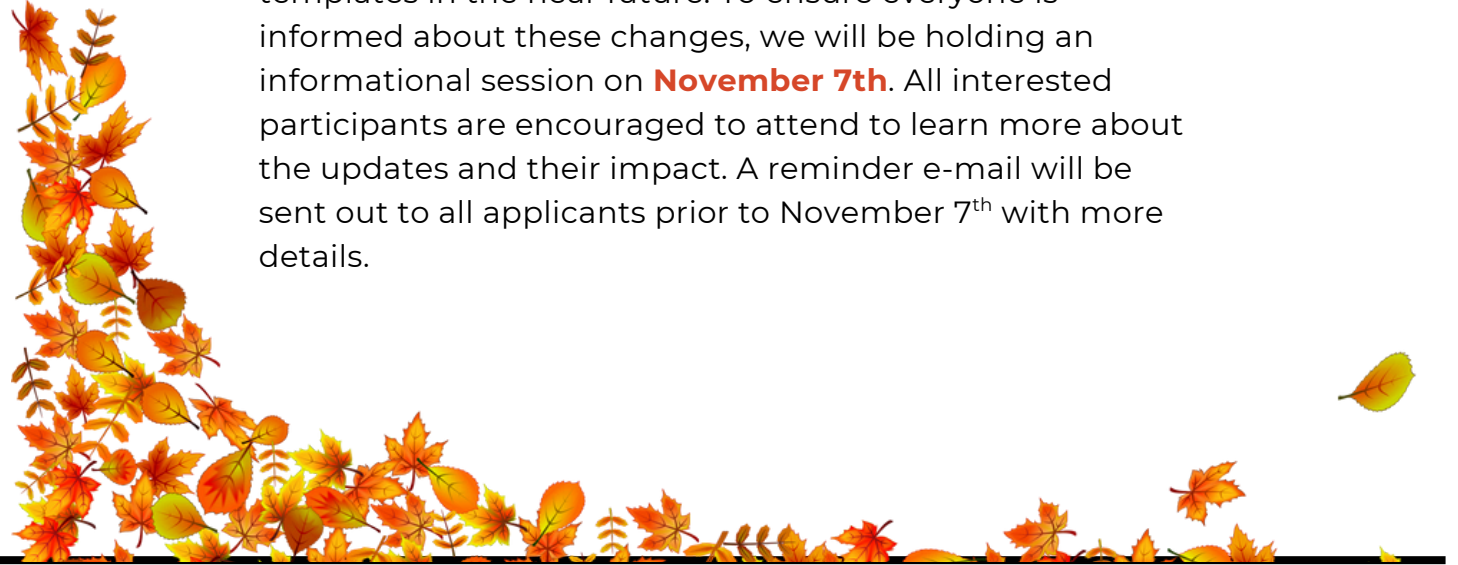

In addition, all Approved Provider Applicants must ensure that every activity is logged in the **NARS system**. Please also note that Approved Providers are required to complete the **Annual Monitoring Report** and submit the associated fee by January 2026.
