A few years ago, our chapter sponsored a Perioperative Nursing Award, formerly the Barb Serniak Award, which was presented to a nurse and/or student new to the perioperative nursing profession. There has been a lack of applicants for this award in the past few years. As a result, the Board has decided to develop new requirements for the award. Once the criteria have been finalized active members in good standing will have the opportunity to apply for the award. More information will follow.

Are you planning to attend the Global Conference and Expo in New Orleans April 11 - 14, 2026? Housing has opened for the conference. The volunteer must be at least 21 years old and be willing to commit to at least 3 RAMP shifts during each year the RAMP certification is valid. RAMP certificates are valid for 2 years.
