A Letter from the President:

Advocacy, leadership, and action.

Why do I advocate for you? What inspires me to be the best leader I can be? What drives you to be the best school nurse or best school nurse leader?

I learned not to prioritize myself last. If I do not advocate for myself and take care of myself, there is no way I can properly take care of others. Part of that self-advocacy was to become involved with ASNC. Being a nurse is very important to me and choosing the specialty of school nursing meant entering an arena that is not understood well by nursing colleagues, educational colleagues, or the community we serve. The only people who really seem to understand the awesome role of the school nurse and how busy we are is the students we serve and see time and time again. They often are our biggest champions and do not have a voice. We advocate for them- it will be years before they are the voting public who can advocate for us. Where does that leave us? We must advocate for ourselves.

One of the best ways to advocate for school nurses is to join your professional organization and be a part of a larger whole. Our voice is louder and stronger in numbers. Now more than ever our local boards of education, town councils and local legislators need to hear from us. They need to know the incredible work we do each day to take care of the youngest citizens in our state. They need to hear what we need to not only do our jobs, but to be healthy citizens as we do our jobs. That health needs to be mental health, physical health, and financial health.

I will continue to lead with a passion to represent and advocate for Connecticut's school nurses and I ask you to do your part to advocate for yourself and other nurses. Introduce work colleagues to ASNC, share your data with your school boards to maintain and increase nurse positions, write your legislators, vote for your own interests and the interests of your community.

In your day-to-day life, advocate for yourself. Set times for your office hours, take your lunch break, close your health room at the end of the day for 15 minutes to catch up on your parent contacts and last bits of charting. We are amazing at the work we do, but we are not irreplaceable except to those who we love the most. Take care of yourself, so you may give to those who love you the most, and you may be present in your life.

Now more than ever is the time to advocate for nurses. For me the focus is to advocate for Connecticut's school nurses. You need to focus on your individual needs within your district. Advocate, lead, and take action to promote school nurses. I am leading ASNC to do that for YOU and to help your voices be heard. Thank you for allowing me that opportunity. Together we are stronger and our collective voice will be heard.

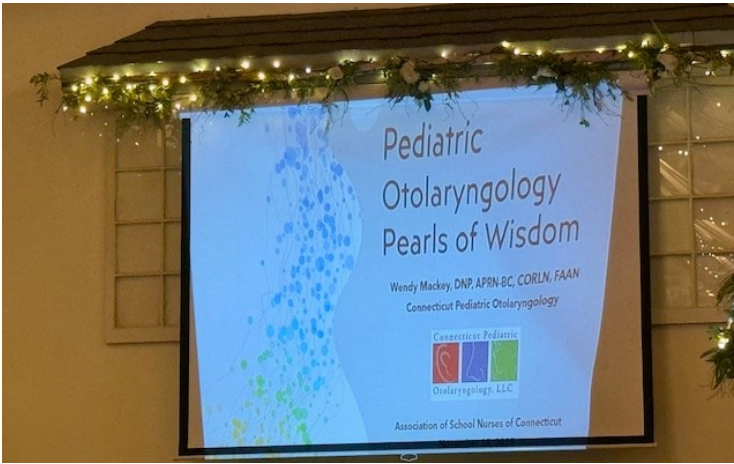

On November 18th, 2025, ASNC hosted ASNC Fall Dinner Meeting– Educational Series at The Pond House in West Hartford. Wendy Mackey, DNP, APRN-BC, MSN, CORLN, FAAN presented Pediatric ENT Pearls of Wisdom for the School Nurse : Otoscope review, seasonal allergies, sore throats, nosebleeds & more.



Wendy educated the nurses in attendance on how to do an ear exam with otoscope and what we should look for during assessment. Some of the topics she covered during the presentation were common ear ailments, hearing loss , hearing tests and how to read and evaluate the hearing test results, amplification, etc.

She also showed everyone how to examine the nose, what we should look for during nasal exam, epistaxis and nasal fractures, etc. Everyone was excited to learn about tonsils, adenoids and commons pediatric ailments.

She ended the presentation with common cold, symptoms and how to treat the symptoms and keep it simple. After the very interactive and informative presentation, the nurses in attendance received 1 CEU.

In a state-of-the-art lab environment and simulation rooms school nurses refreshed their skill set on many commonly seen school scenarios. Don Corne, RN from Somers was able to report he learned the most from the simulated ears. Being able to examine many abnormalities that can be seen within the ear better prepared him for future encounters.



School nurses were able to select four areas of skills to focus on for review and hands-on practice, and then each had a simulation experience in the lab. In this scenario they had information presented and were able to respond in real time to an event that can easily occur on any campus. It was a great environment to practice skills that may not be used daily in school nursing, but need to be maintained.
