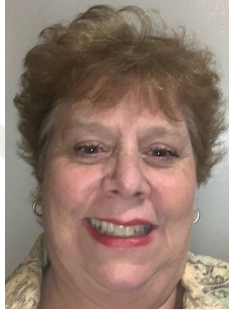

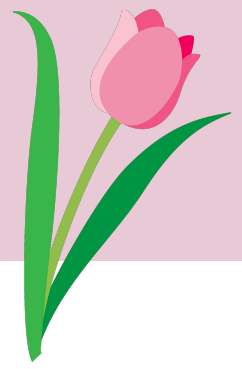

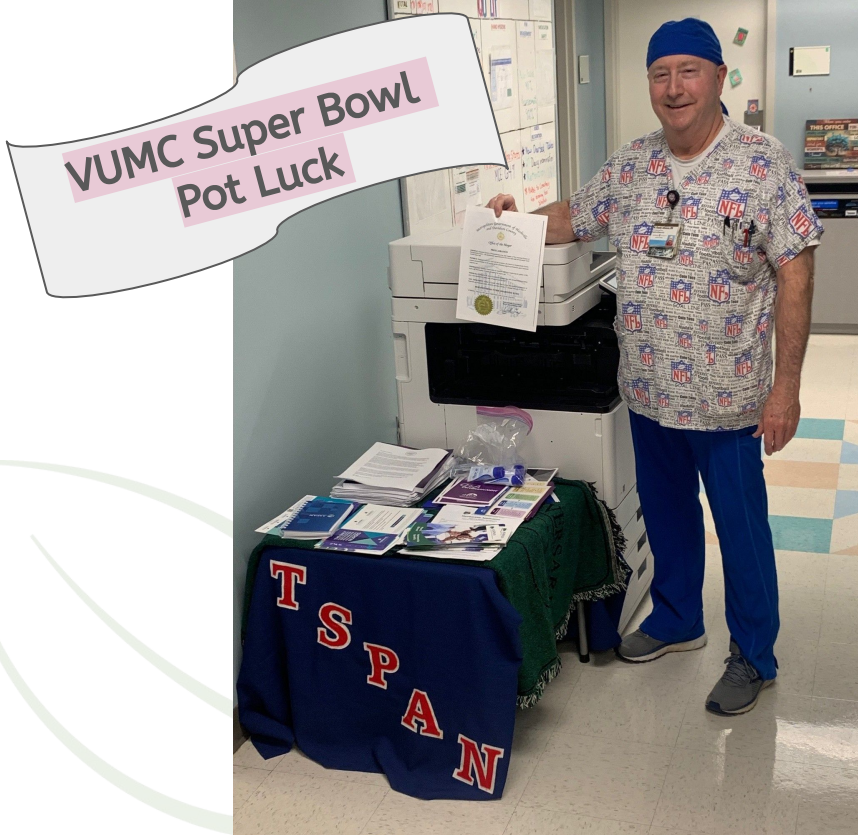

## Perianesthesia Nurse Awareness Week (PANAW) February 2-8, 2026

Nurses working in preanesthesia and postanesthesia care, ambulatory surgery, and pain management are dedicated to caring for patients and their families. PANAW is an ideal time to educate nursing colleagues and the community about the professionalism and care perianesthesia nurses deliver every day. Previously, perianesthesia nurse were celebrated and recognized with the intraoperative staff during November's Perioperative Nurses Week. Nurses that worked in PreOp, Phase I and II Recovery, Extended Recovery, Overnight observation areas were not recognized as its own separate speciality. PANAW week was created by ASPAN. This continues to be promoted by discussions between ASPAN board of directors, National Conference Representative Assembly, along with future meetings with ASPAN, AORN and American Nurses Association (ANA) to recognize perianesthesia nursing as its own speciality.

This year, our president Randy Jones hosted a PANAW presentation alongside his unit's Super Bowl potluck on Friday, February 6, 2026. Nurses are consistently recognized as the most trusted profession in the United States Gallup Poll the past 20 years.<sup>1</sup> Education for advocating for the rights and welfare of patients are embedded in undergraduate curriculum, but nursing's basic philosophy also creates opportunity for advocact for communities, populations and even our profession of nursing. Advocacy is a skillset that can be learned, perfected and within the reach of every nurse. The American Nurses Association (ANA) Nurses Code of Ethics states in Provision 5: "The nurse has moral duties to self as a person of inherent dignity and worth including an expectation of a safe place to work that fosters flourishing, authenticity of self at work, and self-resepect through integrity and professional competence."<sup>2</sup>

The ANA recognizes advocacy as a crucial aspect of professional nurses and political or legislative advocacy is just as important to advancing nursing as well as patient care.<sup>3</sup> In fact, the ANA website hosts a RN Action Center with education and resources for nurses to learn and participate in advocacy.<sup>3</sup>

### **What does nursing advocacy in action look like?**

The American Society of Perianesthesia Nurses (ASPAN) like all professional nursing organizations purpose is to educate, guide/create practice standards, advocate and conduct original research that will advance nursing science for their speciality.<sup>1</sup> ASPAN is a member owned non-profit specialty nursing organization that represents over 600,000 nurses working within the perianesthesia speciality in the United States.<sup>3</sup> APSAN is governed by a board of directors inclusive of 13 voting individuals and the APSAN Representative Assemble which currently includes two representatives from every local component. Speciality nursing organizations can accomplish advocacy work through committees and strategic work teams many times the individual leading these is also the health care policy advocate or a subject matter expert. Establishing organizations' position statements is another avenue to advocate. Multiple organizations collaborating to establish a joint position statement can be extremely powerful in moving a policy forward as it now represents the voice of many nurses, such as the AANA, AORN, and ASPAN Civility Position Statement. Several years ago, President Connie Hardy Tabet was contacted by the Alliance of Nurses for Healthy Environments (ANHE) for ASPAN to join in advocacy work. ANHE was coordinating a White House Roundtable of Nurses focused on climate change. Aware of the work ASPAN been leading on recognition and control of wast anesthetic gases (WAGs) to improve the health of nurses and the climate, ANHE wanted to include ASPAN and the perianesthesia nurse perspective. President Hardy Tabet accepted the invitation sending Dr. Dina Krenzischek and Dr. Elizabeth Card, 2 WAGs scientists and past ASPAN presidents as representatives. The 2-day event included nurses meeting with the White House Climate Committee, key leaders in the Environmental Protection Agency and legislators for discussions on the issues of climate change on health and potential tatics that could be employed. These meetings allowed for establishing relationships and conversations that could continue after the event was completed.

Establishing these relationships and willingness to share our nursing perspective is crucial for success in advocacy activities. Collaborations continued with these groups and during Dr. Alphonzo Baker’s presidency ANHE hosted another event inviting ASPAN. President Baker appointed Elizabeth Card and Dina Krenzischek to represent ASPAN’s perspective and joined them at the event allowing ASPAN to be part of more conversations, increase visibility of the negative impact of WAGs on health. From these continued relationships, recently letters from Healthcare Without Harm, ANHE and the American Association of Nurse Anesthesiology were sent to ASPAN to formally support ASPAN Position Statement of WAGs. In fact, the board of directors from the Nurse Anesthesiology voted unanimously to endorse the work. This allows these organizations to join ASPAN in advocating for cleaner air in the PACU with approximately 750,000 members collectively from all organizations resulted in a powerful advocacy voice.

### How can TSPAN members get involved locally in advocacy?

Currently the ANA is inviting all United States nurses to advocate for our professional status. Webster's dictionary and Wikipedia agree on characteristics that define a profession. These are inclusive of: a specialised body of knowledge, specific training/education, work autonomously, licensure and a code of ethics. The nursing profession meets all of these criteria and is currently listed on the United States Department of Education list of professionals. Formal recognition by the United States Department of Education results in funding for research and education, including limits students may incur on loans. Recently, a bill for the US Department of Education to remove nursing from the list of professionals has come forth. Removal of nursing from this list will result in a reduction in nursing research and ability of future nurse scientists and leaders to successfully fund education leaving a ripple effect that will take years to recover from. The ANA has created resources to help every nurse participate in advocating for our profession and communicating the importance of nursing belonging alongside medicine and law in recognition of our professional status-not a tier below. Please join the ANA in this important work and lend your voice to the conversation by using the QR Code above.

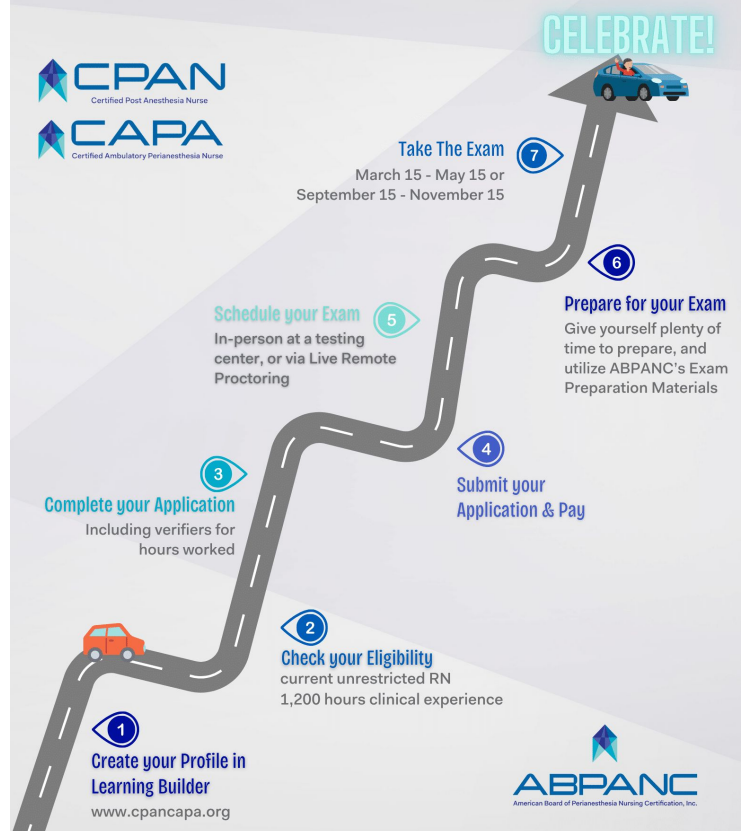
## Take Your Career to the Next Level with CPAN/CAPA Certification!!

- Eligibility Requirements:
  - Unrestricted RN licensure, a minimum of 1200 hours of direct/active clinical perianesthesia nursing two years prior to application

## CPAN/CAPA Recertification

- Recertification every 3 years
- Eligibility Requirements:
  - Minimum of 900 hours of perianesthesia nursing practice
  - Recertification by exam (this option is available until November 2026)
  - Attaining 70 contact hours
    - Contact hours must be uploaded in your Learning Builder

**Spring Recertification Cycle**  
**January 1-April 30**

**Fall Recertification Cycle**  
**July 1-October 31**

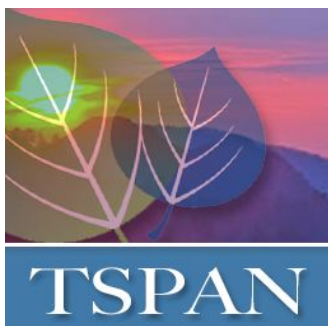
### **TSPAN Scholarships**
