## WORKERS' COMP: EMERGING ISSUES FRIDAY, JULY 29, 2016 – 1515 CLAY ST, OAKLAND

The California Workers' Compensation system is complex. In spite of several legislative reforms, health care providers and others are often perplexed as they try to provide optimal care for injured workers. Innovations in the system exist and are often overlooked. Only by acknowledging and expanding innovative approaches will the workers' compensation system be successful in providing optimal care for workers.

This course will provide insight as well as practical information about common issues in California Workers' Compensation. Additionally, complex and controversial issues will be discussed along with practical approaches to provide compassionate care to injured workers. The presentations will help the attendee understand:

- 1. Factors that play a role in delayed recovery
- 2. Latest approaches to assessing and treating sleep apnea
- 3. How to approach patient care within the Workers Compensation system when there are significant non-industrial factors
- 4. What to expect from Occupational Medicine physicians and working with them to manage cases
- 5. Complex and difficult legal considerations when treating within workers compensation
- 6. Multidisciplinary panel discussions with audience participation exploring gray areas of CA WC

The course targets claims adjustors, attorneys, worker advocates, employer representatives and health care professionals including physicians, qualified medical evaluators, physician's assistants and nurses.

- Identify how clinical guidelines can improve the provision of appropriate health care to workers.
- Understand how to deliver high quality care to patients

- Integrate health and wellness best practices that improve the health of workers both on and off the job.
