Keynote Speaker - Ray Ciancaglini - The Invisible Opponent



In the mid 1960's, as a young up and coming boxer, there was very little known about sports related concussions. No one understood that a concussion is an invisible injury. There are no crutches, no stitches, no swelling or any other visual signs of injury. It is the unseen and the unknown that can cause a concussed athlete to be vulnerable to negative skepticism and peer pressure, which could persuade them into returning to competition before properly healing.

Ray knows all too well the mindset of a dedicated athlete, as determination and desire can sometimes defy common sense and logic. These factors fueled my bad decisions to ignore the symptoms of concussions and "Gut them Out."

A concussion became his invisible opponent, an opponent with lasting repercussions that he battles every day. The general public sometimes looks at him in disbelief because, outside of his Parkinsons Syndrome hand tremors, he ap-

pears in good health. They have no idea the pain and frustration that a brain injury carries with it, all because it is not visible to the eye. Ray has devoted his life to educating athletes about the importance of promptly reporting and being totally honest about their symptoms to a medical professional. He is also devoted to bringing more attention and consideration for individuals enduring a brain disability and to inspire them to never give up ~ just keep punching!

Beverley Bryant Memorial Lecture - Jeff Sebell - My Brain Injury is Not the Boss of Me

Jeff Sebell is an author, speaker, and TBI survivor. He'll discuss the importance of developing self-forgiveness and treating oneself as an individual and not just a brain injury, which are necessary steps for moving forward after this life-changing event.
