1800: Meeting was called to order by Grace Grau, Chair Protem

Grace Grau announced that meetings would be conducted using Robert's Rules of Order.

1801: All members attending identified themselves

1804: Motion made by Brian Dickson to approve the minutes from the previous meeting as posted on the website, second by Norma Cuellar. Passed by majority vote- 4 Nursing Members

1805: Grace Grau opened discussion regarding bylaws posted on website from last meeting.

Dr. Grau explained changes made based review and feedback received from Norma Cuellar and National. The wording was consistent with that of National as follows: Section II was added r/t principal office location:

<u>Principal Office</u>. The principal office of the Chapter is to be located in the Greater Birmingham area of Alabama at a location approved by the Board of Directors.

Dr. Grau added that given the limited financial resources of the chapter, this wording allows flexibility for mailing address thereby preventing expenditure or need for post office box.

Discussion ensued amongst members with unanimous agreement to keep national recommendations for the running of local chapter.

Dr. Grau addressed changes to Section 3: Functions, consistent with National's bylaws as follows:

The Greater Birmingham Chapter of the National Association of Hispanic Nurses (NAHN) shall include, but not be limited to the following:

- a. to have a voice in the planning of health service delivery to Hispanic citizens and residents of Jefferson County and surrounding communities;
- b. to compile a local membership directory of Hispanic nurses;
- to promote leadership, professional and educational advancement of chapter members, particularly the ability of nurse members to meet the healthcare needs of the Hispanic population;

- d. to promote scholarly activities, including research activities and seek grant funding opportunities;
- to support research aimed at evidenced-based solutions that address health promotion, illness prevention, and the improvement of health problems and disparities common to Hispanic ethnic individuals and communities;
- f. to identify the contributions that Hispanic Nurses have made individually and/or in collaboration with interdisciplinary members to advance the development of knowledge, education and nursing practice;
- g. to actively participate in advocacy and setting health care policy that affect Hispanics;
- h. to be recognized and utilized as a resource by community leaders when considering matters that affect the Hispanic population;
- i. to collaborate with all members of national and international organizations to support the health of all people across the lifespan.
- j. to strengthen the influence of Hispanic nurses on government and organized nursing through coordinated action

Dr. Grau emphasized the role of advocacy and health care policy and need to promote scholarly activities, including research activities and seek grant funding opportunities for the chapter to enhance efforts to support Hispanic communities and the professional and educational development of the members through scholarships, etc.

1808: Motion was made by Dr. Cuellar to adopt the bylaws as amended. Second motion received from Jacqueline Godber, RN. Unanimous approval by all members present. No abstentions.

1812: Dr. Grau addressed the need to send chapter dues at the time the bylaws are submitted to National as follows:

- Licensed Nursing members \$25.00/year
- Student/Unlicensed Members \$10.00/year
