| 15. Guest Presentation: Laurie Gehrke | lowa Child Death Review team reviews all accidental deaths, most are MEs cases. The team lost funding and did not meet for 18 months and is now catching up. They have recently finished the 2009 and 2010 reports which should be available on line under the IDPH website office of ME. Laurie reported most deaths are reviewed 1 year after event and any prosecution has completed. ED nurses can assist the death examiner by improving charting observations about the child and the resuscitation efforts. For example, it is essential to know how CPR was performed, (2 fingers on the chest or encircling the chest). ED nurses should use any patient encounter to educate parents or caregivers on preventionespecially sleep related deaths such as co-sleeping, back to sleep, removing blankets from cribs, smoking around children, etc. The team noted that suicide rates are on the rise and they anticipate the numbers to increast to 25 |

| | for 2012-13, the youngest victim of suicide recently was 7 y/o. ED RNs can also help advocate for peds psychiatric help as these deaths are preventable. In 2009 there were 311 child deaths, 62 were ruled accident, 8 suicide, 6 homicide, and 33 undetermined. If you have, further questions contact Laurie and watch IDPH website for report.
