Professional Goals: Earn Your FASPAN

Maybe you're wondering, "What is a FASPAN?" According to ASPAN, FASPAN is one of the highest distinctions the Society confers. It recognizes hard work, significant contributions to perianesthesia nursing, and a sustained commitment to advancing the specialty. In addition to honoring extraordinary accomplishments, being a Fellow of ASPAN offers continued opportunities for professional growth and support of the specialty. The designation was established in 2018, with 17 inductees in the inaugural class. I set a goal to one day join their ranks, and was honored to be inducted as the 31st member

during the opening ceremonies at ASPAN's 44th National Conference in Dallas on April 28, 2025.

Applications open every January. To apply, candidates must hold an MSN or higher, maintain current CPAN and/or CAPA certification, have an active RN license, and provide a CV showing significant contributions in at least two of the following domains: Education, Clinical Practice, Research, or Leadership/Advocacy. Applicants must also demonstrate current involvement in the field through ongoing education, experience, and ASPAN participation (e.g., conferences, committees, Specialty Practice Groups, or Strategic Work Teams). At least one peer-reviewed perianesthesia publication (such as a *JoPAN* article or book chapter) is also required.

Applications are reviewed by the Fellow Selection Team and letters of recommendation from current FASPANs are needed. Selected Fellows are inducted at the ASPAN National Conference. If you're interested in applying, I'd be happy to answer questions or serve as a mentor. Feel free to reach out at rondad@panac.org or rdyer@aspan.org.

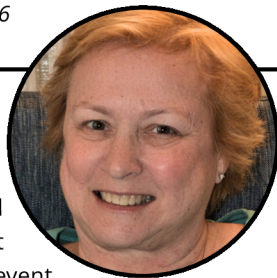

How California Nurses Are Shaping the Future of Healthcare

As healthcare evolves, so must the laws that protect those delivering it. In California, several key legislative efforts are underway, impacting workplace safety, and the future of nursing. That real-world insight is now influencing new laws that could significantly impact our profession.

SB 632 Protecting Nurses on the Job: We all know how physically and emotionally demanding nursing can be. Senate Bill 632 makes it easier for injured nurses to access workers' compensation by shifting the burden of proof away from the employee. Introduced by Senator Jesse Arreguin and supported by the California Nurses Association, this bill is moving through the State Assembly. It is a vital step in recognizing the toll our work can take.

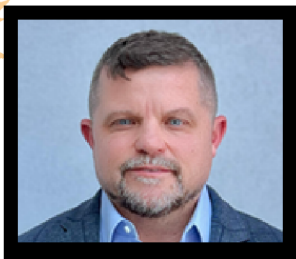
AB 1082 Expanding Clinical Access, Preserving Quality: To address the nursing shortage, AB 1082 would allow students in out-of-state online nursing programs to complete their clinical hours in California, under direct, in-person supervision from licensed California RNs. While this increases access, it raises concerns about site capacity and educational standards. The bill includes safeguards, and if you're involved in education or precepting, this is one to follow closely.

These aren't just policy changes. They affect how we work, how we care for patients, and how we're protected. When nurses speak up, lawmakers listen. Take action and support SB 632 by contacting your assembly representative. Stay involved! Join professional organizations, attend local or virtual meetings, and talk with your colleagues. You don't need to be a policy expert to make a difference. You just need to care. Advocacy begins with awareness. Together, we can shape a safer, stronger future for nursing. One voice at a time.

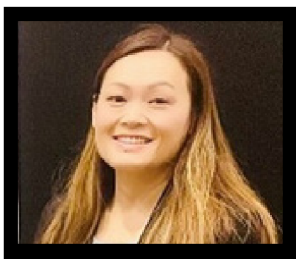

CANDIDATE FOR VP/PRESIDENT-ELECT



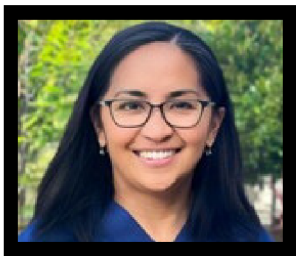

CANDIDATE FOR SECRETARY



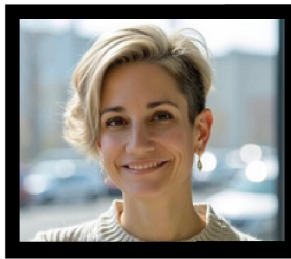

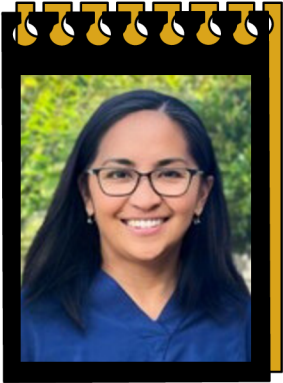

- HIPAN: Annual Conference – Honolulu, HI | Nov 1 (In-person)

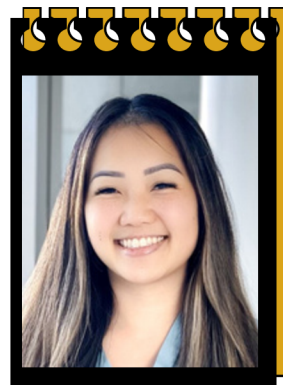

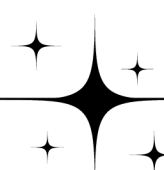

Active warming should be standard in perioperative care to prevent hypothermia and its complications. Through evidence-based practice and staff education, Perioperative Clinical Practice Council (PCPC) successfully implemented an active warming protocol that improves patient care and supports clinical outcomes.

Prevention of Inadvertent Hypothermia by Active Warming in Perioperative Care: An EBP Initiative

Background | Perioperative hypothermia remains a clinical challenge linked to increased morbidity and mortality. Active warming, including forced-air warming systems, is recommended over corrective warming due to its preventive benefits (Su & Nieh, 2018; ASPAN, 2023). In early 2023, Salinas Valley Health Medical Center lacked a standardized approach to preventing inadvertent hypothermia, defined as a core temperature $< 36^{\circ}\text{C}$. A recommendation from the Perioperative Clinical Practice Council (PCPC) highlighted that interventions were primarily corrective, using warm blankets or IV fluids when hypothermia was observed or reported. Professional guidelines recommend preventive active warming over corrective methods (AORN, 2019; ASPAN, 2023). Perianesthesia nurses, Abby Acosta and Sheilah Quentin, developed the following PICO question: In adult surgery patients, how does active warming compared to corrective warming affect patient satisfaction, length of stay, and temperature?

Methods | A literature review was conducted using PubMed®, EBSCO, Google Scholar, and organizational resources. Eighteen sources were reviewed, including six systematic reviews, three guidelines, six randomized controlled trials (RCTs), and three other studies. Active warming was shown to reduce hypothermia, infections, blood loss, and length of stay, and improve comfort and thermal stability. Pre-warming for 30 minutes prior to surgery was widely recommended (Madrid et al., 2016). The proposed protocol included (1) hypothermia defined as $< 36^{\circ}\text{C}$, (2) 30 minutes of pre-warming, (3) active warming during OR cases ≥ 60 minutes and during PACU stay, and (4) exclusion: patient refusal, hyperthermia, or contraindicated conditions. The protocol launched in October 2023

with education, EHR updates, and standardization across perioperative areas.

Results | Following annual competencies, 100% of PACU, OPS, and Surgery RNs were educated on hypothermia prevention. Chart audits showed increased use of forced-air warming post-implementation. Pre-op and intra-op warming became standard for eligible patients. No significant change in PACU hypothermia rates was observed, potentially due to more consistent data capture and increased intervention confidence.

Conclusions | Active warming should be standard in perioperative care to prevent hypothermia and its complications. Through evidence-based practice and staff education, PCPC successfully implemented an active warming protocol that improves patient care and supports clinical outcomes.
