For the purpose of this representation/statement; former owner(s) shall include any person or entity that the County of Sullivan (“County”) acquired title from, in this matter, pursuant to Article 11 of the Real Property Tax Law.
3. I am aware and acknowledge that the County is entitled to and shall strictly rely upon the representation/statement made in Paragraph #2 above.
4. In the event that the County reasonably determines that the representation/statement set forth in Paragraph #2 above was falsely or fraudulently made, then the County shall be entitled to pursue any or all of the following remedies; a) Reject any accepted bid made on behalf of the Incorporated Entity, b) Retain any deposits made by the Incorporated Entity as the Successful Bidder, c) Seek relief in a Federal or a State court proceeding, including but not limited to an action to vacate/declare void any deed transferring ownership from the County to the Incorporated Entity, d) Deny Incorporated Entity the ability to participate in future auctions conducted on behalf of the County and e) Report the conduct to an appropriate police or administrative agency.
5. I have executed this Affidavit knowingly and freely without duress, coercion or intimidation of any kind.
