#### **Soccer Uniforms**

- Reminded that the waiver for soccer uniforms has expired.
- Beginning with the 2016 NYSPHSAA Soccer season, teams will be required to abide by the NFHS Soccer Rule
  4, Article 1, Section 1a, which states: "a. The home team shall wear solid white jerseys and solid white socks,
  and the visiting team shall wear dark jerseys and socks (dark is defined as any color which contrasts with
  white)."

#### **Spalding Ball Adoption Reminder**

- Beginning with the 2016-2017 school year, NYSPHSAA and its 11 Sections will begin a five year agreement with Spalding as the official ball for the sports of Volleyball, soccer, football, basketball, baseball and softball.
- Sections will be provided a specific number of Spalding balls for Sectional play based upon the requested amount from the Sections.
- The "Section" quantity includes all balls needed for Sectional Finals or events staged at a neutral site hosted by the Section. The host school for other sectional events will be responsible for providing the adopted ball for play (i.e. opening rounds of Sectional play).

#### Recognitions

- Nina Van Erk. Has been selected to receive the NFHS Section 1 Citation Award for her contributions to NFHS Section 1 and the NFHS during her tenure as the NYSPHSAA Executive Director. Nina served as President of the NFHS during the 2010-2011 school year and served on the NFHS Board of Directors for a four year term.
- Nina will receive the award at the 2016 NFHS Summer meeting in late June.
- Liam Frawley, Tappan Zee High School Athletic Director, has been named the 2016 NFHS Coach Educator of the Year as recognition for his work on gaining approval from the NYSED for an alternative option for coaching certification. He was instrumental in helping to create a more streamlined process to benefit New York State coaches.
- Congratulated Ed Stores, Executive Director of Section 5 and Karen Lopez, Executive Director of Section 7,
  who will be retiring at the end of the school year. He thanked both for their years of service and dedication
  to the student-athletes of New York.

#### **Championship Advisory Committee**

Minutes from the December 11, 2015 meeting were included in the meeting packet.

#### Championships

- Year to date, the Fall 2015 Championships yielded a \$222,468 net profit, an increase from 2014. Some bills are still outstanding so a final report will be available at the May Executive Committee meeting.
- After presenting a proposal to Warren County for bed tax funding for the 2016 Boys Basketball Championship, we were awarded \$23,000 to be used toward marketing and promotion of the event.
- In collaboration with Time Warner Cable and Track Wrestling, all preliminary and wrestleback rounds of wrestling matches on February 26 will be streamed online. This would mean about 85% of the entire wrestling tournament will now be broadcast online or on television.
- Tickets will be on sale for all Winter Championships by February 1<sup>st</sup> or 2<sup>nd</sup>.
- He gave an update on the experiment with Boys Soccer at Middletown to charge \$8 online using TicketLeap and \$10 on site for walk-up customers. There was an increase of 270 tickets purchased online in 2015 compared to 2014. This experiment is going to be conducted again in the fall and another update will be provided.

#### **Championship Dates & Sites**

• An updated copy of future Championship dates and sites through 2020 was included in the meeting packet.

#### **Fall Intern**

• Introduced Peter Fisher, a senior at SUNY Cortland who has joined us for a full-time internship this winter/spring. He is a former three-sport athlete at Lake George High School (Section 2).

#### **Sport Coordinator**

• The reappointment of George Hathaway as Rifle State Coordinator effective September 2015 will be on the May 2016 Executive Committee meeting agenda.

#### **NFHS National Coaches of the Year Award**

- He congratulated Dom Cecere (Baseball) and Marty Keating (Girls Swimming and Diving) who have been selected as NFHS Coaches of the Year Award winners.
- He has been working with Ron Woodruff to recognize and nominate 20 coaches for the State, NFHS Section 1
  and the NFHS National Award. Announced there were 8 State Award winners, 9 Section Award winners and 2
  National Award winners. All winners will be recognized at the Section level.
- Thanked Ron Woodruff for his time and effort nominating all these well deserving coaches and submitting the paperwork to the NFHS.

#### Website

• Website traffic continues to grow. Overall in November 2015, there were 157,941 sessions compared to 130,959 sessions in November 2014, an increase of 20.6%.

# Website Summer 2016 Update

- Prior to the winter break, a survey was distributed to all athletic directors for feedback on changes they
  would like to see to the NYSPHSAA website at the end of the school year. They were given until January 12 to
  respond to the survey.
- SPIRE, the NYSPHSAA web developer, will be meeting with NYSPHSAA to discuss the results and go through upgrades to the website, which will take place over the summer.

#### Social Media

- Twitter hit its 10,000 follower during the Girls Soccer championships. It now has 10,615 followers.
- During the holiday season, the NYSPHSAA staff participated in the American Dairy Association's special media initiative, Give a Gallon challenge, by having pictures posted of them with milk mustaches.
- Facebook has 3,782 likes, Instagram has 420 followers and YouTube videos have been viewed 113,557 times.

#### **Section 2 Colonial Conference Summit**

- On Wednesday, January 6, he presented at the Colonial Conference student-athlete sportsmanship summit at Siena College.
- He gave three 40 minute presentations regarding NYSPHSAA's use of social media and practices that studentathletes can take when utilizing social media networks.
- Student-athletes shared their ideas of what initiatives on our social media networks would interest them and enhance our coverage of student-athletes throughout the year.

#### **Live Scoring-Golf**

- NYSPHSAA has switched providers for its golf live scoring platform following some issues that came up during the 2015 NYSPHSAA Boys and Girls Golf Championships.
- Starting in 2016, we will utilize GolfStat, which is used widely throughout the NCAA and in a number of other state associations.
- Information regarding the use of GolfStat at the Sectional level has been distributed to Section Coordinators.
- Both the Boys and Girls Golf committees supported the change to GolfStat.

#### **Media Relations**

- Concerns raised by media during the Fall NYSPHSAA Championships have been addressed with tournament directors and state coordinators.
- Media has started to use our Dropbox account to acquire video and photographs for print and broadcast.
- During Championship weeks, weekly media advisories were distributed each Monday to statewide media alerting them to media contracts at tournaments, deadlines for credential requests and tournament schedules.

#### **NYSPHSAA Championship Recognition Day at CitiField**

- On Sunday, May 22, the New York Mets will be holding NYSPHSAA Champions Recognition day at CitiField.
   They will be playing the Milwaukee Brewers at 1:10pm.
- The Mets are setting up a separate website and providing promotional materials for the event. Details will be passed along to all member schools.
- Their Community Relations Department has a listing of all NYSPHSAA team and individual champions for the Spring 2015 and Fall 2015 seasons and will be provided a list of Winter 2016 champions at the conclusion of the winter championships.

#### **Special Programs Coordinator Kristen Jadin**

#### **Scholar Athlete**

- There were over 3,400 Scholar-Athlete teams.
- A list of the Fall 2015 Scholar-Athlete State Champion teams was provided.
- The deadline for the Winter 2016 Scholar-Athlete Team Awards is Monday, March 14, 2016.

#### **Captains Club**

- It is a motivational phone call put on by her with a leadership message to all team Captains in our member schools as a way to try to inspire and motivate Captains.
- The first Captains Club took place on Tuesday, January 12 at 3pm. Over 275 Captains, AD's and coaches registered.
- The next Captains Club is Tuesday, February 9 at 3pm. A link to register has been distributed to all Athletic Directors.

#### **Battle of the Fans**

- On Monday, January 11<sup>th</sup> the NYSPHSAA staff evaluated the Battle of the Fans videos sent in to the office.
- Three finalists were chosen; Webster-Schroeder HS (5), Cicero-No. Syracuse HS (3) and Skaneateles HS (3).
- NYSPHSAA staff will visit each school and then create a video to post on our website, Twitter and Facebook.
- Voting will take place through social media.
- The Battle of the Fans Champion will be announced Friday, February 12<sup>th</sup>. A presentation will be made during a sporting event or school wide assembly following the NYSPHSAA Winter Championships.

#### Life of an Athlete Committee

Life of an Athlete Committee will transition to Student Athlete Development Committee pending approval.

#### **Student Athlete Advisory Committee**

- The development of this committee is pending approval at this Executive Committee meeting.
- She contacted 15 students who attended the New England Student Leadership Conference and 10 of those students are interested in being members of the first Student Athlete Advisory Committee.
- The next meeting is scheduled for February 10<sup>th</sup> via conference call. An application process will be established for future SAAC members.
- Once the committee is approved, a mission statement and goals will also be established.

#### Other

 President Steve Broadwell tasked her with reviewing the current NYSPHSAA Scholar-Athlete program, to look at everything including the team champion component and report back at the May Executive Committee meeting.

#### **Director of Sales and Marketing Chris Joyce**

#### **Past Experience**

• He reviewed his past work experience.

#### **Meeting Attendance**

Reported on the different meetings he had attended; Boys Basketball Bid meeting, Track & Field Bid meeting,
 NYS Federation Meeting, National Athletic Directors Conference, Championship Advisory Committee meeting and the NYSPHSAA Executive Committee meeting.

#### **Responsibilities to Date**

- Has worked with Joe Altieri to review all of our existing sponsors.
- Has compiled a prospect list of potential sponsors and partners.
- Developed sponsorship levels with corresponding deliverables.
- Revised proposal templates for varying partnership types.
- Scheduled preliminary meetings with sales prospects.
- To benefit the Association and fans, he is starting to explore ticketing platforms to streamline all of the ticketing options such as the printing of tickets and the online platform all being from one source, being able to process credit cards at the gate and mobile ticketing.

# Frank Venezia, Auditor-Marvin & Co.

- Reviewed the Association's audited financial statement stating a "clean opinion" was issued on the Auditor's report.
- On the Balance Sheet he noted the current ratio was 3.65 to 1 and that the Association was in a very good financial position.
- On the Income statement, the decrease and the change of net assets from 2014 to 2015 was due mainly to a \$250,000 decrease in the market value of investments and a \$100,000 increase in Post-Retirement Health Benefits.
- Thanked Lisa Arnold for her support and the work she has done.

#### **Treasurer Lisa Arnold**

- Reviewed the Balance sheet noting:
  - The Association continued to have a good solid cash position.
  - The Other Receivables of \$290,000 includes the second installments due from American Dairy and Time Warner Cable.
  - The adjustment for the Post-Retirement Health Benefit from Sound Actuarial Consulting was approximately \$162,000 due to the Actuary using an updated mortality table from the IRS and projecting people living longer which they did not do in the past.
  - Championship revenue for Fall 2015 netted over \$200,000 to date, an increase of \$50,000 over Fall 2014
  - Under Programs and Committees, the cost of Scholar-Athlete pins was \$25,500, a major cost of the program.
  - The market value of our investments increased from 8/31/15 by \$36,757 but turned around in January.
- Overall the financial health of the Association continues to improve.

#### **Legal Counsel Renee James**

- Reported we are seeing the effects of the change in the Transfer Rule in that there are fewer appeals.
- She is seeing a trend in using undue hardship for health and safety, bullying and other types of hardships to request a transfer and sending schools not having back-up documentation.

• Parents, not schools, are taking appeals to the Commissioner who has denied the request for stays in several cases.

#### **SECTION CONCERNS**

#### Section I

- Reported they are getting feedback in their Section that Spalding balls are very highly priced on the ed
  datasheet. Robert stated if anyone is seeing a dramatic increase in the price of balls to please let him know.
   He can also provide a preferred vendor list.
- They requested a discussion item for the May Executive Committee meeting be how officials are selected for State Tournaments, specifically in Wrestling and Ice Hockey.
- It came to their attention last spring during the Softball Regionals, the Section that is hosting is not necessarily the host team which differs from Baseball. They would like this revisited. Robert reported this was discussed at the Section Executive Directors meeting on January 26<sup>th</sup>. It will be on the agenda of the April 6<sup>th</sup> meeting of the Championship Advisory Committee. Cathy Allen, NYSPHSAA Softball Coordinator, addressed Section 1's concern of using a coin flip to select the home team. She stated it was brought up at their June committee meeting and was unanimously approved by the committee to not go to home plate being the home team due to the way Regional rotations are set up, it would be unfair to some teams who travel more than once.

**Section VII** has the same concerns as Section I regarding the cost of the Spalding balls. Karen would like a list of the preferred vendors.

#### **Section XI**

- Had a concern with Cheerleading and the Mixed Competition Rule as it pertains to the Co-Ed Division. It is not consistent with any other sport.
- Voiced a concern with their BED's numbers due to the recent increase of undocumented students in Suffolk
  County. Many of these students are not eligible to participate in athletics so they don't know why they
  should be included in their BED's numbers. Robert will have a conversation with Section XI representatives.

#### The Every Student Succeeds Act (ESSA)

Commissioner Maryellen Elia stated the new law still has to be reviewed closely as there are questions about
evaluations, assessments and accountability. She stated the Act will let New York move forward to
implement new, higher standards and improve our schools and to help our students build better lives
through education.

#### **ESSA Quick Facts**

- School health and physical education are identified as part of a student's "well-rounded" education.
- School districts will be able to access funding from Title I, Title II and Title IV through their state department of education. SED will communicate how that will be accomplished when more information becomes available.
- Funding previously allocated to school districts through the Carol M. White Physical Education Program from the US Department of Education will no longer exist. Funding available in the block grants through Title IV will replace the PEP grant funding.
- ESSA funding for Titles I, II and IV will begin to flow to states on July 1, 2016. The regulatory and
  implementation process for accessing funding will be developed during the first half of 2016 by the US
  Department of Education and Congress. SHAPE America will keep members updated as this process
  progresses. SED will communicate more information in the future as it becomes available.

#### **REPORTS FROM STANDING COMMITTEES**

# Budget and Audit Committee. Jim Osborne, 1st Vice President

- The committee met on January 28, 2016 via teleconference to review the first draft of the 2016-2017 Budget.
- Thanked Lisa and the committee for their time and hard work.
- Noted the Association is in good financial shape.
- The committee discussed and agreed to propose the following at the May Executive Committee meeting:
  - Increase the Sport Coordinator's stipend.
  - Increase the transportation rate from \$1.30 to \$1.35.
  - Establish the January Executive Committee meeting to be a face-to-face meeting next year.
- Reported at the October 2015 meeting, the Executive Committee approved the 2016-2017 membership
  dues, ticket prices for the 2016-2017 championships and the Association will pay for the competition lift
  tickets at the 2016-2017 Skiing Championships.
- The committee's next meeting is scheduled for March 21, 2016 at 10:00 AM.

#### **Championship Advisory Committee.** Assistant Director Joe Altieri

- The committee met on December 11, 2015 via teleconference. The minutes were included in the meeting packet.
- Gave status updates on the reconvening of the Championship Philosophy Committee, Baseball's proposal for a 2-day tournament format and Girls/Boys Lacrosse going to 4 classes.
- The committee supported the following proposals to be presented for action at the January 2016 Executive Committee meeting:
  - **PSAL Participating in Girls Tennis**. Background information was provided by Joe Altieri along with rationale and budget impact.
  - Cheerleading-Fee & Structure of Judges. Joe reported the Executive Committee postponed the
    October 2015 vote to accept \$137 plus mileage for cheer officials and asked the CAC to revise the
    fee. Todd Nelson provided additional information including the fees for other sports and average
    fees.
  - **Football 6**<sup>th</sup> **Classification**. Gary Vanderzee, Football State Coordinator, presented background information on the 6<sup>th</sup> classification progress which included a special meeting at the Carrier Dome before the Football Championships where it was determined by the Football Committee to leave the classification in Football as is for 2016 and 2017.
- Input and feedback was provided on the Outdoor Track and Field site bid for 2017 and 2019 as well as for the Boys Basketball site bid for 2017, 2018 and 2019.
- A concern was brought by the Section Executive Directors regarding how officials are assigned to games in State Tournaments. This will be brought to the January Executive Committee meeting.
- The next meeting of the CAC is scheduled for April 6, 2016 at 10:00 AM in the NYSPHSAA office.

# Handbook Committee. Patrick Pizzarelli, Chair

- The committee met on December 18, 2015 via teleconference.
- The committee discussed the mandatory attendance of all member schools at the annual eligibility workshops. They agreed if a member school has no varsity programs, attendance should still be required.

- Reported the NCAA currently has wording in their rules and regulations to address the issue of a single soccer official. It states, "It is permissible to conduct a soccer game with a single official provided both teams agree to a single referee before the game begins." The committee supported the wording. This will be a discussion item later at today's Executive Committee meeting with potential approval at the May 6, 2016 Executive Committee meeting.
- Back on September 16, 2013 the Handbook Committee discussed whether ineligible students should be able
  to practice but not compete in a game/contest. The committee discussed it again at this meeting as Robert
  has had a few schools request discussion on this item. The committee reaffirmed that ineligible students
  should not practice.
- At the October Executive Committee meeting, a proposal was discussed for a revision to the Practice Session Rule allowing athletes who switch from one sport to another be permitted to count conditioning practices toward their new sport. Currently, NYSPHSAA does not allow student-athletes to carry over practices when going from a "contact" sport to a "contact" sport other than in our State Championships. This revision would create consistency for all Students and sports. The Handbook supported this proposal.

A **motion to approve** revisions to Rule 22 "Practice Sessions" as follows: *Athletes who switch from one sport to another are permitted to count conditioning practices toward their new sport as follows (excluding bowling, golf and rifle)* **carried.**Mullins/Greene

#### Life of an Athlete Committee. Special Programs Coordinator Kristen Jadin

- The committee met on January 6, 2016.
- Concerns from the committee regarding a name change to the Student-Athlete Advisory Committee were reviewed. The committee unanimously voted to recommend keeping the name. Patti and Thad were adamantly opposed to a name change. They felt the Life of an Athlete program would eventually disappear with the turnover in Athletic Directors. We need to keep the name consistent especially because the Life of an Athlete program is thriving in some schools. Newer members supported Patti and Thad due to their experience and history with the committee. The newer members also wanted to make sure there would be no subcommittee or additional committee developed. Todd James, Section 4, would like to see Life of an Athlete maintain its name but if a name change is being considered, he would like to see the vote postponed so the committee could discuss it further.
- Since the mandate freeze, Life of an Athlete has not received the funding they need.
- She noted the Association's goal is to put all student-athlete based programs including Scholar-Athlete, Life of an Athlete (chemical health), Student Leadership, Captains Club, Community Service under one umbrella to rebrand ourselves to set up for expansion in those areas.

# Safety Committee. Assistant Director Todd Nelson

#### **Heat Index and Wind Chill Procedure**

- In discussion with AccuWeather and Weather Bug to finalize the manner in which our member schools can reliably and accurately obtain the hear index and wind chill temperature for the area of their school or contest.
- Met with AccuWeather on January 27, 2016 who is proposing a portal service where each school would have a license to use this service which is extremely reliable and accurate for the location of the school's event.
- Todd and Chris Joyce will be working with AccuWeather to finalize a partnership and a possible sponsorship agreement.

- He is also still in discussion with Weather Bug.
- More information to follow with a possible recommendation at the May Executive Committee meeting.

# **Modified Committee.** Assistant Director Todd Nelson

- Their Spring meeting is scheduled for April 1, 2016 at the NYSPHSAA office.
- Asked for schools involved with the football pilot program to send their Fall injury reports to him. The
  committee will be discussing reports from last year and the year before to make a recommendation to move
  forward and make the rule change permanent, or to keep the old rule.
