



APPLICATION FOR MEMBERSHIP

Upon acceptance of my request, I agree:

1. To pay annual fees and any other charges in amounts fixed by The Club in monthly installments. I understand the method of payment is via an automatic draft payment plan. I understand any fees are subject to change.
2. To abide by the rules, regulations, policies and procedures of the Club and such rules, regulations, policies and procedures as may be prescribed by The Club and are subject to change from time to time. These changes may be communicated via email, newsletters, or The Club website and that it is my responsibility to read and understand such changes.
3. I understand I have the privilege of charging expenses to my membership account and agree to pay those charges after the close of each month.
4. The Club will have the right to establish rules, regulations, policies and procedures applicable to guests of members. Such rules, regulations, policies and procedures may be modified or varied from time to time so as to best serve members and the interests of The Club. Privileges attributed to guests may be modified, varied, denied, limited or withdrawn at any time for reasons considered sufficient by The Club in its sole and absolute discretion. Guests will be entitled to employ and enjoy the Facilities based on the rules, regulations, policies and procedures that are determined by The Club from time to time, and on the basis that the guests pay the required fees applicable to them. The member shall be responsible for all charges incurred by their guests. Guests must adhere to the rules, regulations, policies and procedures established by The Club. The Club shall have the right to determine whether the guest is complying with all rules, regulations, policies and procedures of The Club and it is determined that if a guest does not comply, The Club shall have the right to require that the guest leave the Facilities.
5. That my membership obligation is through June 30, 2021. I may resign my membership at that time with written notification to the General Manager by June 1st and will owe no further financial obligation to The Club after June 30th. I understand all club privileges cease on this date. Membership resignation requests will not be granted during the above term without The Club approval for qualifying events.
6. If I do not notify The Club of my resignation, then I choose to continue my membership and I become financially obligated for the annual membership fees for the next membership billing year. I understand the membership billing year is from July 1st of one year through June 30th of the following year and that I am obligated for annual membership fees each year I am in active membership status on July 1st after my initial membership period has expired.
7. If my request is approved and if married, we agree any and all charges are our joint obligation. If I/we default in payment of any obligation, I/we may owe to The Club, I/we agree to pay all costs of collection, including reasonable attorney fees.
