Enrollment Contract

Both parents, guardians, and other persons responsible for payments should read all the provisions of this Contract, complete the required information, sign and return the Contract to **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ** (Our School). A student is accepted for enrollment or re-enrollment when the Contract has been delivered to **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ**, countersigned and dated. A copy of the accepted Contract will be returned to the Center Manager within the first full week of student's attendance. No amendment to this Contract and no alteration or addition to the printed terms hereof will be effective without the express prior written approval of the Osage Nation Director of Operations.

In consideration of the acceptance of this Contract by the **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ**, the undersigned agrees to pay the required TOTAL FEES for each month and any additional fees incurred and agrees to be bound by the provisions of this Contract. So long as tuition payments are not delinquent, tuition payments are due no later than the 10th of each month at the rate of \$200 per month. On the 11th of each month a \$25.00 late payment fee will be added to your monthly balance, the full balance must be paid by the 30th of the month to avoid expulsion.

Enrollment and Re-enrollment is conditioned upon the following terms:

1. Successful completion of the current academic year and recommendation of **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ** is required for re-enrollment of currently enrolled students.
2. Tuition payments must be received by **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ** on or before each monthly due date.
3. Acceptance of enrollment constitutes an agreement to pay each full academic month's account, comprised of both TOTAL MONTHLY FEE and all related fees and expenses of the student. **ՃԼԲՕՏՅԱ Ա՚ՅՕԾԼԵՐՈՒ** is entitled to be reimbursed for any attorney's fees and costs incurred in the collection of any unpaid balance.

4. The student and the student's family agree to comply with and be subject to ᏓᏳᏅᏍᏔ ᏱᏪᏍᏓᏳᏅᏍᏔ rules and policies as set forth in the Parent Handbook, as amended from time to time.
5. An account is considered delinquent if not paid on or before the 10th calendar day of each month. A late payment fee of \$25 per month, or fraction of a month, will be charged on a delinquent account. Whenever a tuition or fee account becomes past due for a period of 30 days from its due date then the student will be withheld from classes until the delinquency is cured. If the delinquency is not cured within an additional 30-day period, the student will be dismissed. In all events, all past due tuition payments must be paid on or before the first day of school or the student's place will not be reserved. The student will not be enrolled in classes.
6. Parents/Guardians are required to regularly attend Osage language classes as a condition of their student's enrollment. Parents/Guardians are allowed three (3) unexcused absences per quarter without consequence (a list of consequences for exceeding three (3) unexcused absences can be found in the Handbook). Students will not be allowed a reduction in fees for allowed/excused absences.
7. Student's shall receive a 25% reduction in tuition per week when parents/guardians, or other adult household member, attend a weekly Osage language class/cultural event (provided or sanctioned by the Osage Language Department, Immersion School, or Osage Cultural Department). Student accounts shall receive a maximum of an 100% tuition reduction for language class attendance.
8. Parents/Guardians receiving financial assistance are responsible for all co-payments, fees, and unpaid balances under the above terms of this contract.
9. Students must attend at least 85% of all immersion instruction each month. Absences will be excused and not counted toward the 85% when absences are excused due to illness, family crisis, planned family vacations or other verifiable circumstances.
10. The undersigned hereby expressly recognizes that the benefit sought or presently enjoyed by the undersigned from the Osage Nation government, to wit, enrollment of my child in ᏓᏳᏅᏍᏔ ᏱᏪᏍᏓᏳᏅᏍᏔ is a privilege and a benefit to the undersigned and not a property interest or matter of right. In consideration of, and as a condition precedent to, the grant, issuance or continued enjoyment of this privilege and benefit, regardless of whether the undersigned is a natural or artificial person or entity, and further regardless of whether the undersigned is of Indian or non-Indian blood, descent or legal character, the undersigned hereby stipulates and agrees that jurisdiction over all matters and disputes arising out of exercise of such a benefit and privilege shall vest in the Osage Nation Trial Court. The undersigned further stipulates to be bound by all Osage Nation laws, codes, regulations, policies and procedures governing such benefits, privileges and activities. The undersigned further expressly waives all further rights to contest the jurisdiction of the Osage Nation Trial Court over any such matters, disputes, actions or decisions of any branch of the Osage Nation government.
