## c. Phillips 66 - Pipeline - Steve Beavers

Steve Beavers gives an introduction of those with him. Mr. Beavers says Matt McCutchen will do presentation. Matt McCutchen says they are just trying to be transparent with the pipeline they are building and the issues they are encountering. Mr. McCutchen says they are replacing an existing twelve-inch pipe that begins in Ponca City, Oklahoma and terminates in Glenpool, Oklahoma and constructing a forty-six-mile segment between Ponca City, OK and Hominy, OK. They are seeing a high volume of rock on surface and subsurface. Their question is what they are allowed to do with the rock. Typically, they can either haul off the rock or crush it and bury it in the subsoil. Councilman Revard asks the original width of the right of way. Steve Beavers says sixty feet, they asked for an additional twenty feet for temporary workspace. There are some areas that are on private property, so they only have fifty feet, so they asked for 30 feet of temporary workspace. He says some of the landowners would be willing to take that rock for drainages and low-lying areas and they wanted to see if it was okay to let them take the rock on the same property. On the restricted area they would like to push it out of the existing right away and push it off to the side and feather it out so that it does not restrict operations. Councilman Revard asks what type of rock it is. Mr. Beavers says mostly sandstone. Councilman Revard asks Chairman Waller if there is a market for sandstone. Chairman Waller says yes. Second Chair Cheshewalla says the big chunks end up at Lowe's being sold. Councilman Shackelford says that that is something we should look further into. **Second Chair Cheshewalla** asks if they are having archaeological issues. Mr. Beavers says that it was all coordinated with Dr. Hunter's office and there are no archaeological issues. Where there are possible areas of concern, they go underneath the area. Chairman Waller says the council needs a chance to review this and they need to get more clarity on the rock. Mr. Beavers asks if it would be best to pile it into bigger piles in case the council decides it has market value. Chairman Revard asks if there is one section that is more urgent. Mr. Beavers says they are moving forward.

## d. Committees - Councilman Bighorse

Councilman Bighorse says that he believes committees should be reinstated. Councilman Revard says that two categories that he would like to see is the budget committee that he would like to be on and chair. He also would like to see a code of federal regulations committee or an oil and gas regulatory committee. Councilman Shackelford says this sheet is just a template to add or take away from. The idea on the executive committee was to oversee the office. The budget would fall under the executive committee. This just gives structure and process. There are five names three will be on the committee and two ex-officio. Councilman Cheshewalla says that he talked to some ex-employees, and they said they would help coordinate the lease sales. Councilmember Revard says he agrees that it would be beneficial to have meetings one what we can do to improve. He says he asked the Superintendent last year whose lease sale it was, and she said it was the Bureau of Indian Affairs lease sale. He said do we have our own lease sale in addition to their lease sales and he thinks it is a discussion we should have, and he would like to be a part of that conversation. Councilman Shackelford says that we have a geologist that works in our office and our geologist must know the data on these wells so that he can inform them on which ones have value. So that we can have a better-informed opinion.

e. Councilman Revard says since our agendas are subject to change, he would like to discuss Osage 2. He thinks because all the controversy and concern he would like to rescind resolution 4—530 to approve Wah Zha Zhi Thompa and their pursuit for non-profit status or other status for more opportunities marginal well production for the Osage Reservation.

## f. Raptor - Advanced Recover - Jim Hessert

**Jim Hessert** introduces his company Raptor. He brings up partner who gives background. He states that their technology is advanced and will improve production in stripper wells. Third partner, John, explains the technology using microbes and some case studies and the changes in production that they have seen. He says in one case they treated over 90 wells and seen an increase in 70%

in production. Jim Hessert says discusses CO2 and how Osage county is to shallow for that and how expensive they are. It also combines with water and makes everything acidic. He suggests the Minerals Councils looks into some way to assist in helping with their data because he believes the effort that they have now is extremely week. Councilman Revard asks what are you proposing for us to do. Mr. Hessert says he wants to help the Minerals Council to help them get into producing by screening and applying their technology. He states the Minerals Council technical efforts in advanced recovery techniques are minimal at best. Councilman Revard says that we have an orphan well list that could probably benefit from these techniques and we should keep this in mind as we evaluate them, and we should share that information with that group.
