4. Superintendent Report - Cammi Canady

Ms. Canady states the superintendent report is as follows: Total oil produced 314,169.74, royalties paid \$3,792,620.01, total gas produced 166,333 MCF, royalties paid \$52,291.74, total gas liquids 147,650 gallons, royalties paid \$16,329.55, total tank bottom 48.68, royalties paid \$184.57, water usage royalty paid \$225.00, waste disposal royalty paid \$7,608.96. Rentals/Bonus – Oil and Gas Rentals Paid \$864.07, Oil and Gas Bonus Paid \$0.00, Rental \$400.00, Saltwater Easement Rental \$3,900.00, and Late Payment Charges \$506.97. Aggregates - APAC produced 25,644.75 tons and paid \$31,235.31 in royalty (September). Candy Creek Crusher produced 11,597.82 tons and paid \$11,203.49 in royalty (August). Burbank Materials produced 14,414.46 tons and paid \$17,729.78 in royalty (August). Rocky Banks produced 168 cubic yards and paid \$140.00 in royalty. Wilson Ranch produced 0 tons and paid \$0 in royalty. Schmidt Brothers produced 288 cubic yards and paid \$216.00 in royalty. Sherwood Construction produced 0 cubic yards and paid in \$0 in royalty. Mr. Stone asks that the Council consider three leases (Ross, Laura Lee, Lynn) that has previously been terminated. Councilman Cheshewalla asks is Mr. Stone had any of these leases previously. Mr. Stone replies no but he had pumped them before. Chairman Waller asks about the terms and Mr. Stone states 20% royalty, \$4700 bonus, and 3 year primary term. Councilman Revard clarifies that the Superintendent has verified that these lease are available. Councilman Shackelford calls for the vote.

b. SCS Engineers UIC Engineers Class I well – Carrie Ridley & Doug Boyd Ms. Ridley introduces the Mr. Boyd, counsel for AEL and Mr. Boyd briefly outlines the current operations of American Environmental Landfill and their proposal to drill a Class I injection well. Chairman Waller asks if this well would be opened up for commercial use. Mr. Boyd replies that it is for AEL use exclusively. Chairman Waller asks how many barrels will be injected each day. Councilman Revard responds that by his calculations, it would be 514. Councilman Revard asks if AEL is aware of any active oil and gas leases near the area. Mr. Boyd responds that there are none. There is further discussion regarding EPA, state permits, and Osage permits. Ms. Ridley shows and discusses the presentation that has been shared with the Council. Councilman Redcorn asks what AEL would be paying elsewhere to dispose of this waste and asks that AEL determine the figure and let the Council know. Ms. Ridley states that any questions may be directed to her.

c. Osage Prairie Resources - Oil Lease - Denton Collier

Mr. Collier states that he is interested in the SW/4 of S3-T21N-R10E. He states that E.W. Carter would be the lessee and he would be the operator. **Mr.** Collier continues that there are a few repairs that need to be made but should have the well up and going in a few months.

b. Well Plugging - Second Chair Red Eagle

Second Chair Red Eagle states that the Executive Branch gave us three options regarding the well plugging grant via email from Candy Thomas. Those three options are 1) Establish partnership with a MOA defining roles and responsibilities, 2) OMC
