CALL TO ORDER

Chairman Everett Waller called the meeting of the Osage Minerals Council to order at 10:00 A.M.

OPENING PRAYER

Councilman Talee Redcorn gave the opening prayer and read the list of deceased Osages.

NEW BUSINESS

Oklahoma Geological Survey:

Kyle Murray, Ph.D., from the Oklahoma Geological Survey gave a presentation that was presented to the Council regarding Sub-Surface pressure monitoring and if there's a complex interrelationship between oil and gas production, water production and seismicity that he and his group studies at OGS. His status is water and how it's managed throughout the entire system inside. Ella Walker, Water Resources Engineer, was also recognized.

New Oil and Gas Lease: Dr. Edgar Rebeiro and Jamie Sicking, Attorney

Mr. Sicking spoke on behalf of Dr. Rebeiro, who lives in Tennessee, and had the lease that is in question, where there was trouble with the water. He was able to receive an easement for a Salt Water Disposal well on a neighboring lease, and turned out to have many problems. Therefore, he shuts it down, reworks it, and by the time he had the Salt Water Disposal well done, his lease had been terminated for lack of production. The BIA asks him to come plug the Salt Water Disposal well that he put \$100,000 into that never got used. Therefore, Mr. Sicking is asking that the lease be renewed and to get an easement back for his Salt Water Disposal well. BIA Superintendent, Robin Phillips, made sure that he was asking for a new oil and gas lease, and that he will need that easement, and it was confirmed by Mr. Sicking. He appealed her decision to plug that well, and that he needs to negotiate a new oil and gas lease, and will need the easement. Council discussed this matter with Mr. Sicking. BIA Superintendent asked for this request in writing, as she had nothing in front of her.

Burbank Materials - Renegotiation of Royalty Rate per January 4 letter: Casey Hindman

Mr. Hindman explained his proposal to negotiate the royalty rate on two of his contracts for rock mined there. He also proposed to pay a 10% royalty rate on determined fair value of rock based on a per ton rate, and has delivered to the Council an addendum to what he is already proposing. After discussion, Chairman Waller said that the Council would review the information.

Rocky Banks & Schmitt Brothers: Sandy Soil permit

Chairman Waller announced that this will be taken into the Executive Session.

Councilwoman Boone asked why Mr. Shannon's presentation would go into Executive Session, as she's getting calls from shareholders that they are not for his lease. Chairman said that Council should hear it in Executive, and if necessary, it will come out in open session.

TORP - University of Kansas: Councilman Redcorn

Jim Hessert gave a presentation on how to get more oil out of the ground with advanced techniques. After the presentation, Councilman Redcorn asked that at the next meeting (Feb. 15), that the Minerals Council could get involved with the Tertiary Oil Recovery Program (TORP) at KU. They want to develop several demonstration projects in Osage County. They're very interested in doing that. Mark Ballard is the gentleman that's telling the Council that they want to come down and demonstrate in Osage County what they do in Kansas.

Washington, D.C. Trip - March 13-16, 2017:

Councilwoman Erwin mentioned that Principal Chief Standing Bear had been scheduled to go on another trip there, but did not go. His non-elected administrative people went instead, and she's appalled that these people went up there discussing the Council's business with the U.S. Senate Committee on Indian Affairs.

Julie Wilson, Shareholder:

Ms. Wilson asks why the Council about Mr. Shannon's presentation is in Executive Session, and not in Open Session.
