ADOPTION OF SCHEDULE OF COURT COSTS

1. Under 5 ONC 1-114, the Chief Justice of the Supreme Court is responsible for establishing a schedule of the court costs for "various filings and actions of the Court and shall require advance deposits of such court costs for such court functions."
2. The Chief Justice approves the attached "Schedule of Court Costs", which is incorporated herein by reference.
3. Under 3 ONC 1-103: "When the Osage Nation is a party plaintiff to a suit, it shall not be required to advance or pay court costs, but it may recover all costs against all defendants which a private litigant would be authorized to recover, including reasonable attorneys' fees."
4. This administrative order supersedes any prior inconsistent administrative orders.
