Addendum to AO-2020-01 - COVID-19 Protocol Administrative Order No. AO-2020-02

Following the March 19, 2020 *Proclamation Declaring a Public Health State of Emergency for the Osage Nation*, the Chief Justice issues this addendum to AO-2020-01.

The Court maintains a capacity for conducting business remotely, and many court operations can and will continue without interruption so parties can file requests for temporary and emergency orders as needed, pay fines, and file pleadings as needed.

The following measures are now in place through the duration of the *Proclamation Declaring a Public Health State of Emergency for the Osage Nation* or until withdrawn by administrative order.

- 1. Court Operations and Services:
 - a. Court facilities remain closed to the public.
 - b. Trial Court Clerks are onsite on a reduced, rotating schedule to limit exposure.
 - c. Filings and other business with the courts shall occur in accordance with the attached *Notice*.
- 2. Scheduled Hearings/Trials:
 - a. Trial Court judges shall coordinate with the court clerks to reschedule civil and criminal trial court hearings scheduled for the next month while the *Proclamation Declaring a State of Emergency for the Osage Nation* is in effect.
 - b. Trial Court judges shall continue to issue all necessary orders to extend filing deadlines and to toll speedy trial if needed after balancing the interests of justice and public health and safety.
 - c. Emergency motions, ex parte hearings, or hearings for temporary protective or guardianship orders shall be conducted by telephone.
- 3. Personal appearances/attendance:
 - a. To minimize exposure, Court appearances are no longer permitted.

If you are **filing a new case which requires a filing fee by mail**, the filing fee (money order or cashier's check only) should be included with your petition.

If you are **filing either a pleading or a new case electronically** (by E-mail or fax) please read and follow the directions in Administrative Order No. 2013-06, Electronic Filing Rules, which can be found at https://www.osagenation-nsn.gov/who-we-are/judicial-branch/administrative-orders. If you are **filing a new case which requires a filing fee electronically**, the filing fee (money order or cashier's check only) should be included with the original petition when it is mailed within five (5) days of electronic filing per the Electronic Filing Rules, Administrative Order No. 2013-06.
