#### • 6:15PM **MMC Strife**-Kim Summarizing

- MMC having strife within APP counsel regarding new contracts including non-compete clause (this passed at Federal level but was struck down by courts, failed to pass ME House), no more merit based raises
- Rhianna motions to Ad Hoc meeting to further discuss the Maine Health pay restructuring at another day
- Kathleen seconds
- No objection

### • 6:25PM **Education Committee Update**-Kathleen

- 2024 Conference Planning
  - CME offerings (20.5 hrs, 4 workshops)
    - Budget/Finances (equipment purchase)
    - Staffing needs (front table, introductions)
    - Exhibitor Update-(Rhianna)
      - 12 registered
      - \$17,650 currently with goal of \$20,000, will likely pass this goal
      - Chris added that equipment reps tend to be easier to work with overall
- o 2025 Conference Planning
  - Looking at venue options. Membership survey returned with western/mountain region in fall or winter.
  - Steph brought up possible bad weather, losing money, etc if we select a ski venue
  - Kim discussed changing timing to not coincide with PA week. Chris added we need to be mindful of PAEA and Leadership Advocacy Summit
- NERLC/NH Conference Planning
  - MEAPA is planning to host the next NERLC in partnership with NHSPA
  - Location and timeframe are being decided upon.
  - First annual was in Connecticut in June
    - Here, they discussed membership, advocacy, finances
- Increasing CME offerings to aid with membership benefits, potentially can do this via online/website hosting.

#### • 7:00PM **GAC Agenda**-Kim

- PA Compact passed, there will be a meeting in September with all the states that passed it, 24 month estimated operational start date
- Professional Title Change (State)

- AAPA completed their title change in 2021.
- Speciality and State organizations are starting to accomplish this.
  - MEAPA Board has voted to change to "Maine Academy of Physician Associates" (still MEAPA), this is pending a full membership vote (October)
  - On state level, our primary objective for this or next board year is professional title change, the first state to do this was Oregon last April.
     AAPA is going to focus on 5 states strategically, we are on the list to be chosen but if we are not chosen, grant funding should still be available.
- Moose Ridge Contract
  - \$47,000 for work on title change from Sept to July
  - \$42,000 for work on title change from Nov to July
  - Will ask for \$40,000 from AAPA
  - Pre-session Planning Nov-Dec '24
  - Session Work Dec '24-June '25
    - Also includes managing Medical Provider of the Day, reactive bill tracking, testimony etc.
- Organization Name Change (Two town hall meetings, in person membership meeting to discuss all before electronic vote during the conference)
  - Full membership vote will coincide with bylaw vote during conference, sent electronically to member emails
- Medical Provider of the Day (Statehouse)
  - PAs will be covering one week per month while in session.
  - We need a PA for each day of that week.
  - Plan to respond to emergencies and be ceremonially recognized by both chambers.
  - Children can page need to be at least second grade.
  - Chris asked if PA students can join along with PA of the day. Lydia will circulate this around the second years.
- AAPA LAS Attendees we are looking for MEAPA Board members to attend.
  - In Washington, DC, Sept 12-14
  - Set up appointments on Capitol Hill to meet with state constituents
  - MEAPA Budgeted \$5000 for two MEAPA BOD's to go

#### • 6:40PM **HOD Summary**-Steph

- AAPA has issued a strong statement to AMA regarding the "scope creep" campaign against PAs.
- Recommend MEAPA move forward with title change to match AAPA, other recommendation to collaborate with UNE to also change program/degree title
- Recommend to continue to protect OTP efforts
- Recommend to include DEI based language. Need to make this more robust.
- Recommend not limiting PAs to DMSC and would allow them to pursue other doctorate degrees (there are 4-5 that PAs can pursue at this time, which are not exclusively for PAs)
- HOD voted in favor to provide retirees full fellow membership, with voting rights
  - Currently our two retiree membership types do not having voting rights
  - Steph motions to allow Maine retired PAs to have full fellowship membership to MEAPA for free. Rhianna seconds.

- Discussion as a group to maintain the current two levels (Emeritus and Honorary, which is based on lifetime achievement/awards) which should remain free membership but now with full voting privileges
- Chris motions to give full voting privileges to MEAPA Emeritus and Honorary Membership types. Kathleen seconds.
- No objections, motion passes
- o Currently no language on using AI, currently fraudulent to use this technology
- Chris added UNE is waiting to see what MEAPA does with title change and believes they will follow suit when MEAPA changes. In regards to doctoral degrees for PAs, does not anticipate UNE to offer any PA directed doctorate degree, he recommends we do not take a position on something we do not offer in the state.

#### • 6:55PM **Budget Discussion/Adoption vote** -Rhianna

- had \$15,000 extra (due to unbudgeted \$20,000 AAPA PA Compact grant)
- Mooseridge contract and AAPA GAC title grant are not included on this budget, will have a separate electronic vote when we know if this will be happening
- Also not accounted for on the budget Maine Professionals Health Program (MPHP) for providers referred. We have not contributed since 2016. We had previously been sending in \$500 contribution annually - this is also their current ask.
  - Kathleen asked if we can we make contribution in honor of recent PA loss
  - Rhianna motions to continue contributing \$500 to MPHP annually per bylaws
  - Kathleen seconds
  - No objection, motion passes
- Budget with new line items for award expenses and, CD interest accrued
- Rebecca motions to pass the budget as written with the addition of \$500 to MPHP
- Kathleen seconds
- No objection, motion passes

### Bylaw Updates-Kim/Angie

- Corporate policy reviewed and updated in 2021, no changes to Administrative policy at that time
- Bylaw index needs significant overhaul, which since it is non substantive can be updated later without full membership vote.
- Major Changes include:
  - This includes changing title throughout the document
  - Steph given narrow window to update DEI statement to the more robust version during this round of updates, if unable to provide in time, can be included in future revisions.
  - Eliminated antiquated language regarding paper ballot voting, etc
  - Tweaked members need to be AAPA in order to be MEAPA
  - Susan Vincent Memorial Scholarship separate bank account/fund ran out many years ago. This account has been eliminated from bylaws, though MEAPA will continue to award from general funds at increased award to \$1500/year.
  - "CME Committee" name changed to "Education committee"
    - Kim also recommended that the committee start to plan to reach out to local high schools and present the PA career.
- New bylaws regarding LAS, AAPC ELC, NERLC attendance GAC and Executive Board get first dibs on attending their respective events.
  - Northeast Regional Leadership Conference (NERLC) we are planning to host,
     Chris wondering if we may be able to have UNE host

## • 7:20PM **Awards Committee Update**-Kathleen

- Three awards we give out each year, looking for nominations, social media posts/website.
  - Robert J Lamptham Advocacy award
  - PA of the Year Award Service and community award
  - Outstanding Health Professional of the Year Award Teaching/Precepting
  - Student Scholarship increased to \$1500 from \$1000
  - Presidential Service Award for MEAPA Board members, volunteer service, July 1-June 30, count hours and log them, once approved, minimum of 100 (earns bronze) goes up to silver and gold based on hours. Hours can count over time as years of service.
