What advice do you have for someone thinking about entering your profession?



What advice do you have for someone thinking about entering your profession?



What do you enjoy doing in your time away from work?


Gardening and stopping at random garage sales.



Growing up, I wanted to be a math teacher. I still enjoy working with numbers and helping kids learn different ways to apply math and algebra skills to daily life.





What advice do you have for someone thinking about entering your profession?



What advice do you have for someone thinking about entering your profession?


