

Puppet, Inc. – Beta Agreement (On-Premise Software)

BY INSTALLING OR USING THE SOFTWARE (AS DEFINED BELOW), YOU HEREBY AGREE TO THE RIGHTS AND OBLIGATIONS OUTLINED IN THIS AGREEMENT (THE “**AGREEMENT**”) AND YOU ARE REPRESENTING THAT YOU HAVE THE AUTHORITY TO BIND THE PERSON OR COMPANY THAT WISHES TO USE THE SOFTWARE (THE “**COMPANY**”) TO THE PROVISIONS OF THIS AGREEMENT, AND ARE UNCONDITIONALLY CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. COMPANY’S CONTINUED USE OF THE SOFTWARE SHALL ALSO CONSTITUTE ASSENT TO THE TERMS OF THIS AGREEMENT. IF COMPANY DOES NOT UNCONDITIONALLY AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, DO NOT INSTALL OR USE THE SOFTWARE, OR IF INSTALLED, UNINSTALL THE SOFTWARE. IF THESE TERMS ARE CONSIDERED AN OFFER, ACCEPTANCE IS EXPRESSLY LIMITED TO THESE TERMS.

LICENSE. Subject to the terms of this Agreement, Puppet grants Company a temporary, nonexclusive, non-transferable limited license to use the beta version of certain Puppet on-premise products and related documentation (collectively, “**Software**”). The Software will be made available to Company at Puppet’s discretion and solely for testing and evaluation purposes prior to such Software becoming generally available. There will be no fees charged to Company for this limited license. Company may not use the Software other than for testing and evaluation of its functionality and operability for potential use with Puppet’s commercial products, and Company may not rent, lease, sell, sublicense, assign, or otherwise transfer the Software. Company may not modify, combine, copy, reverse engineer, decompile, or disassemble the Software. Company shall comply with all laws applicable to it.

CONFIDENTIALITY. The Software is proprietary to Puppet and/or its licensors and any information relating to the Software is confidential information of Puppet. Company agrees not to provide the Software or any information relating to the Software (including the results of Company’s evaluation or testing) to any other party without Puppet’s prior written consent. Unauthorized use or disclosure of the Software may cause irreparable harm to Puppet, and Company agrees that Puppet may seek injunctive relief of any threatened or actual unauthorized use or disclosure of the Software, and Company agrees to promptly report any unauthorized use or disclosure to Puppet. The parties agree that entering into this Agreement or the sharing and/or exchange of confidential information shall not give rise to any intention, commitment, promise, or legal obligation (i) to buy, sell, or enter into any kind business relationship; and (ii) with respect to Puppet’s products, to deliver any material, code, or functionality. As such, any confidential information shared and/or exchanged regarding development, release, and timing of any features or functionality of Puppet products remains at Puppet’s sole discretion.

PROPRIETARY RIGHTS. Company acknowledges that all rights and title in and to the Software are owned exclusively by Puppet and/or its licensors and are protected by United States copyright laws and international treaty provisions. Any reports, developments, recommendations or modifications made by Company relating to the Software (“**Feedback**”) are the sole property of Puppet. Feedback may also include, but is not limited to, survey responses, bug reports, user experience feedback and, if Company consents, Puppet recording his/her voice and or image, from any audio or visual recordings. Company hereby assigns (and agrees to assign) to Puppet any interest it has or may acquire in any Feedback, including any intellectual property rights, and will cooperate to perfect or further evidence such assignments. All Feedback shall be Puppet’s sole property and confidential information. Except for the limited license as expressly provided in Section 1, Company obtains no rights with regard to the Software.

USAGE DATA. Company agrees that Puppet may collect and use information automatically generated by the Software regarding Company’s use of the Software, which includes without limitation browser and operating systems types and versions used, installer commands, IP addresses, URLs visited within the Software, error messages and related data about Software errors, web interface clicks, mouse gestures, data relating to the submission of online forms (but not form input data), IP addresses, page views, URLs visited within the Software, error messages and related data about Software errors where Software is hosted by Puppet or its providers(s) or Company or its providers(s) (the “**Usage Data**”) and Company consents to such collection and use per this section. **Company cannot disable this functionality in beta versions of the Software.** The Usage Data collected and used by Puppet is de-identified so that it does not reveal the name, role, contact details or other real world identifiers of Company’s users. In all cases the Usage Data collected shall be Puppet’s sole property and confidential information.

5. **AUTOMATIC UPDATES.** If the Software is installed on servers or devices with access to the internet, **the Software will automatically update when an update is available. This feature cannot be switched off.** Removal of these files may cause errors in the Software and the original files may not be recoverable. By installing this Software on a server or device, Company consents to these running on that server or device.

6. **TERM; TERMINATION.**

6.1 The effective date of this Agreement is the date the Software is installed (the “**Effective Date**”) and remains in force until either party gives written notice of termination.

6.2 Either party may terminate this Agreement or Puppet may terminate the license for a specific beta version of the Software, without the need for cause, upon five (5) days prior written notice to the other party. Upon termination, Company shall immediately cease use of and return all copies of the Software without modification to Puppet. Company agrees that its obligations regarding

Puppet proprietary rights and non-disclosure of information shall survive termination of this Agreement. Neither party shall be obligated to enter into any further agreement or license with respect to the Software.

6.3 The parties agree that the terms and conditions of the Agreement shall apply to Company's limited license for the beta versions of the Software made available to Company by Puppet; provided however, Company agrees that once a particular beta version of the Software is made generally available, this Agreement will automatically terminate with respect to that beta version of the Software.

7. WARRANTIES, LIABILITY. The Software is a "beta" version, and as such, is licensed without support or maintenance. Puppet provides the Software "AS IS", WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, PUPPET AND ITS LICENSORS FURTHER DISCLAIM ALL EXPRESS OR IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, OR ANY IMPLIED FROM THE DOCUMENTATION. COMPANY ASSUMES ALL RISK ARISING OUT OF THE USE OR PERFORMANCE OF THE SOFTWARE. THE SOFTWARE MAY CONTAIN BUGS, AND WILL NOT NECESSARILY OPERATE ERROR-FREE OR PER ITS DOCUMENTATION. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL PUPPET, OR ITS OWNERS, OFFICERS, DIRECTORS, EMPLOYEES, OR LICENSORS, BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING CLAIMS FOR LOSS OF DATA, USE OR REVENUES, OR ANY OTHER PECUNIARY LOSS, WHETHER ACTION IS BASED ON TORT (INCLUDING NEGLIGENCE), CONTRACT, STRICT LIABILITY, OR ANY OTHER THEORY, EVEN IF COMPANY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

8. GENERAL. The Software is subject to United States export laws and regulations. Company must comply with all domestic and international export laws and regulations that apply to the Software. These laws include restrictions on destinations, end users and end use. The laws of the state of Oregon, U.S.A., govern this Agreement. The parties shall resolve any dispute that arises from or relates to this Agreement exclusively in the federal or state courts located within Portland, Oregon. If a court finds any provision of this Agreement to be invalid or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect and such invalid or unenforceable provision shall be deleted. Company may not assign its rights and/or duties under this Agreement without Puppet's prior written consent. Any assignment in violation of this will be null and void. The parties agree that there are no third party beneficiaries of this Agreement. This Agreement contains the entire agreement of the parties with respect to the subject matter and supersedes all previous communications, representations, understandings, and agreements, either oral or written, between the parties with respect to said subject matter. This Agreement may not be amended, except by a writing signed by both parties.
