TEN (10) YEARS

STANDARD DOORS guarantees all PVC components against defects in material resulting in peeling, blistering, flaking, corroding or rotting for a period of ten (10) years from original date of purchase.

ONE (1) YEAR

STANDARD DOORS guarantees all parts, including hardware against material defects for a period of one (1) year from original date of purchase.

TWENTY (20) YEARS

STANDARD DOORS guarantees its glass panels against the formation of condensation or dust deposits on inner surfaces, caused by seal failure, for a period twenty (20) years from the original date of purchase.

TEN (10) YEARS

STANDARD DOORS guarantees its tempered safety glass against spontaneous breakage (interior surface only) for ten (10) years from the original date of purchase.

ONE (1) YEAR

STANDARD DOORS guarantees its service for one (1) year from the original date of purchase.

CONDITIONS

- 1- These guarantees are valid provided the attached "**REGISTRATION OF GUARANTEES**" has been completed and signed by the purchaser and returned to **STANDARD DOORS** within 120 days of purchase.
- 2- All claims under these guarantees must be made to our local dealer, in writing with reference to the guarantee registration number and a copy of your proof of purchase, within the stated guarantee period.

- 3- Replacement for a part claimed defective under the terms of these guarantees will be invoiced and shipped to our dealer's place of business, prepaid or collect, depending on conditions of original sale. A credit note equivalent to the part value will be issued upon inspection of the part claimed defective and confirmation by **STANDARD DOORS** of part defectiveness.
- 4- These guarantees will be invalid under any of the following circumstances:
 - ♦ if damage of any kind is caused by careless handling, misuse, abuse, negligence, fire or Acts of God
 - ♦ if doors were not installed in accordance with the installation instructions enclosed with each **ODYSSEY**
 - ♦ if damage is caused during building construction and/or prior to building being occupied by owner or tenant(s)
 - ♦ if **STANDARD DOORS'** conditions of sale have not been wholly complied with
 - ♦ if, with respect to the insulated glass guarantee, the panel has been subjected to stresses caused by , without limiting the generalities of the foregoing, the concentrated action of heat, the movement of building walls, or a usage contrary to **STANDARD DOORS'** recommendations.
- 5- This "Statement of Guarantees" constitutes our only warranty, sets forth our complete and maximum liability hereunder and excludes any other warranties. No other representations or warranties expressed or implied are made by **STANDARD DOORS**.
