This fun piece for the young band will be a favorite of students and parents alike. For a proper performance be certain that the eighth-note rhythms are articulated, long-short ("rib-bit"). Keep a steady tempo throughout with attention to the dynamic contrasts. The spoken frog sound, "rib-bit," should not be shouted but understated, as in the background. At m. 61 work for an even rhythmic exchange between the upper and lower voices.
