This matter having come before the Court upon the Complaint filed by plaintiff Mike Coney (“Plaintiff”) and the accompanying Motion, the Court hereby finds that Plaintiff’s Motion be GRANTED, and this Court enters Judgment and injunctive relief in favor of Plaintiff, against defendant “anonymous” on the websites www.consumercomplaintdepartment.com and www.pissedconsumer.com (“Defendant”), as outlined below. Plaintiff and Defendant are hereby collectively referred to as the “Parties.”

JUDGMENT

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Defendant has posted false and disparaging statements regarding Defendant on the Internet, including on www.consumercomplaintdepartment.com (“Consumer Complaint Department”) and www.pissedconsumer.com (“Pissed Consumer”).

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the statements posted about Plaintiff – located at:

PERMANENT INJUNCTION

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

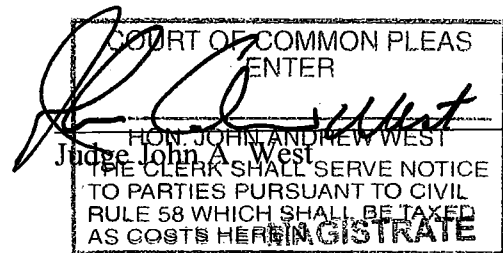
- i. Defendant and his or her agents are prohibited from any further acts of defamation or publication of false statements, comments, or information regarding Plaintiff on Pissed Consumer and Consumer Complaint Department or other public-facing websites;
- ii. The Parties are mandated to personally remove all defamatory, disparaging, libelous, and false statements about Plaintiff that Defendant posted on Pissed Consumer and Consumer Complaint Department, and also to request that Pissed Consumer and Consumer Complaint Department remove the defamatory, disparaging, libelous, and false statements published by Defendant about Plaintiff, including those found at the following URLs:

The Parties are mandated, as it is foreseeable that the above-referenced URLs and statements contained thereon will be referenced on additional webpages in the future including, but not limited to, index, directory, and search results pages, to take all actions available under the law to remove all such web pages from the Internet, including requesting removal from the Internet search engines Google, Yahoo!, and Bing, of all such webpages.
