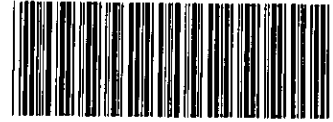

) ORDER GRANTING JUDGMENT AND ENTRY OF PERMANENT INJUNCTION

Defendants.

This matter having come before the Court upon the Complaint filed by plaintiff MyAirbags Inc. ("MyAirbags"), and the accompanying Motion, the Court hereby finds that MyAirbags' Motion be GRANTED, and this Court enters Judgment and injunctive relief in favor of MyAirbags, against defendants "Team Ohio," "RobertAuto," and "do not trust myairbags" on the website www.ripoffreport.com and "ryanapolis" and "anonymous" on the website www.pissedconsumer.com (collectively, "Defendants"), as outlined below. MyAirbags and Defendants are hereby collectively referred to as the "Parties."

PERMANENT INJUNCTION

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- a) Defendants and their agents are prohibited from any further acts of defamation or publication of false statements, comments, or information regarding MyAirbags on Ripoff Report and Pissed Consumer or other public-facing websites;
- b) The Parties are mandated to personally remove all defamatory, disparaging, libelous, and false statements about MyAirbags that Defendants posted on Ripoff Report and Pissed Consumer, and also to request that Ripoff Report and Pissed Consumer remove the defamatory, disparaging, libelous, and false statements published by Defendants about MyAirbags, including those found at the following URLs:
