\$80 for the first graduate-level program and \$50 for each additional program

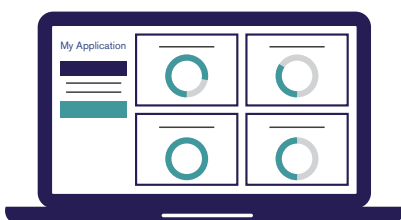

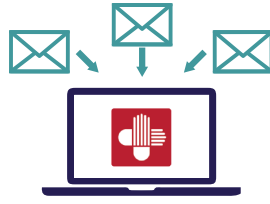
