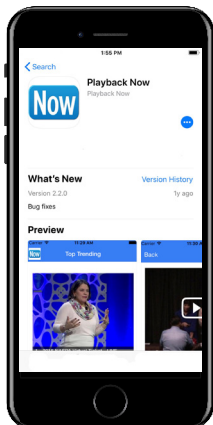

How soon will I have access to my presentations?
