

Assumption of Risk, Release and Indemnity Agreement for Minors

I certify to the CDM Community Church (CDMCC) that I am the parent and/or legal guardian of the minor person whose name is printed below (hereafter, "my child") and that I have full authority to sign this document on behalf of my child and to legally bind my child to the terms of this document. In consideration of my child being permitted to enter upon, use and/or observe for any purpose the premises, facilities, equipments, services and programs of CDMCC and any on-site or off-site program affiliated with CDMCC, I, for myself and my child and each of our heirs, executors, personal representatives and beneficiaries, hereby acknowledge and agree as follows:

I hereby certify that my child is physically and mentally capable of safely participating in CDMCC programs. I assume full responsibility 1. for all risks of bodily injury, death, and property damage, whether or not due to the negligence CDMCC, its directors, officers, employees, contractors and/or agents (hereinafter referred to as the "CDMCC" Parties), while my child is in, upon, using and/or observing for any purpose the premises, facilities, equipment, services and programs of CDMCC and/or any on-site or off-site program affiliated with CDMCC, including without limitation, the risks of thrown, kicked or batted balls, falling objects, uneven ground, holes in the ground and automobile accidents. Prior to allowing my child to enter, use or participate in any such premises, facility, equipment, service or program, I will inspect and carefully consider the risks associated therewith and will not register my child for or otherwise permit my child to enter, use or participate in any such premises, facility, equipment, service or program unless my child is physically and mentally capable of safely doing so an I am willing to assume all such risks.

I hereby release, waive and discharge all of the CDMCC Parties from, and covenant not to sue any of the CDMCC Parties for, any and all 2. actions, causes of action, damages, claims and demands whatsoever (including, without limitation, for personal injuries, death and property damage) which I or my child ever had, now have, or hereafter can, shall or ay have, arising out of or in connection with my child's entry upon, use and/or observation for any purpose of the premises, facility, equipment, service or program of CDMCC and/or any on-site or off-site program affiliated with CDMCC, whether the same arises or is caused by the sole or joint negligence of any CDMCC Party or otherwise, and whether the same is now known or unknown, foreseen or unforeseen. I acknowledge and agree that this is a perpetual release of all personal injury and other claims and is intended to cover each and every present and future occasion on which my child enters upon, uses and/or observes any purpose of the premises, facility, equipment, service or program of CDMCC and/or any on-site or off-site program affiliated with CDMCC.

I hereby agree to indemnify and to hold harmless all of the CDMCC Parties from and against any and all claims, actions, damages, losses, 3. liabilities, costs and expenses of any nature whatsoever (including, without limitation, reasonable attorneys fees and expenses), whether known or unknown, foreseen or unforeseen present or future, that any CDMCC Party may incur or suffer as a result of or in connection with my child's entry use and/or any onsite or off-site program affiliated with CDMCC, whether the same arises or is caused by the sole or joint negligence of any CDMCC Party or otherwise, and/or any certification made by me in this document which is not true and correct in any respect.

I hereby irrevocably grant to the CDMCC Parties my permission and the full right to (a) obtain and authorize medical treatment for my 4 child in the event of injury or other emergency and (b) use for promotional and all other legal purposes any photographs, videos, recordings and any other record of my child upon or using premises, facility, equipment, service or program of CDMCC and/or any on-site or off-site program affiliated with CDMCC

5. I hereby agree that CDMCC has the right to suspend and/or terminate my child's participation in any and all CDMCC services and programs for non-payment of dues or fees, or for behavior that interferes with the enjoyment of the CDMCC by other participants, staff or for any reason deemed sufficient in the sole discretion of CDMCC. All CDMCC dues and fees are non-refundable except as may be otherwise stated in writing by CDMCC.

I understand and agree that this document is intended to be as broad and inclusive as is permitted by the laws of the State of Florida and that if any portion hereof is held invalid, the balance shall continue in full legal force and effect. No representations or statements of inducement have been made to me. I HAVE READ AND AM VOLUNTARILY SIGNING THIS ASSUMPTION OF RISK, RELEASE AND INDEMNITY AGREEMENT.
