We received great news that our periodical, Paper Money magazine was awarded the NLG Award "Best Not-For-Profit Periodical Small Circulation" in Rosemont, IL, August 2021 at the recent ANA convention. Many thanks to our Editor Benny Bolin and our contributors for this great achievement. This is a testament to the quality of the articles and columns you all submit.

Thanks to the hard work and effort by our Editor Benny Bolin, Board Member Loren Gatch, and Vice President Robert Calderman, the index to articles in Paper Money magazine from Vol.1 to Vol. 60 is complete. It breaks down to 2400+ articles. 546--obsoletes, 517-Nationals, etc., etc. Most prolific authors M. Owen Warns--63, Forrest Daniel--75, Gene Hessler--81 and Peter Huntoon--270! It is searchable by author, category or by year. We are making a final decision on how to distribute this tool to the membership.

This year I had the opportunity to attend the Long Beach Expo for the first time. The dealers I spoke with indicated that sales had been strong. The Long Beach show was interesting because it had not only numismatic items, but also had sections for both stamps and sports cards. Shortly after I left the hall, I received a text message from our Librarian Jeff Brueggeman informing me that they had called my name for a door prize. Sadly, I was not there to claim it. I heard it was an autographed jersey and not a numismatic-related item.

Long ago, collector and dealer Tom Flynn and I were discussing if we should each go buy a note that a dealer had two left. Tom finally got up from his table and said, "I'm going to go buy one because my list of 'wish I had' is a lot longer than my list of 'wish I hadn't." I got up with him and we proceeded to buy the two notes. However, on the other side, I think each of us has sold a note that we now wish we still had. The note that makes me lose sleep is one of the two known 1934 \$500 Minneapolis star FRNs. Serial numbers 799 and 800 exist. The 799 note sold in the Heritage Auction this past Long Beach show. Years ago, I bought the 800 note from Tom Denly but at a show a few years later, I was convinced sell it to a dealer who wanted to own a consecutive pair of the notes. I have tried to keep track of who has my serial number 800. At the Long Beach show, my friend Jhon E. Cash was there and was kind enough to let me hold my old 800 note for a photo but was clear to mention that it is not for sale.

With this being our 60th anniversary, our editor Benny asked each of us to reflect on how things have changed over the years. The thing that really comes to mind for me is how third-party grading has affected our hobby. There was a time when a 1928 or 1934 note with a counting crease in the upper right corner was ignored and considered a Choice CU or better note. Now, it is often a gamble that the note will come back as a 58 grade losing the CU classification. At first, I was opposed, as were many others, to third-party grading. Over time I realized that third-party grading had opened a whole new direction for the hobby. It made it safer for collectors to buy notes sight-unseen either at online bidding or dealer sites or from auctions than it was previously. But there are still plenty of un-slabbed notes out there that collectors shouldn't overlook since the cost of submitting them to a third-party grading service often doesn't make sense for the lower-priced notes.

Thanks to efforts by our Vice President Robert Calderman, we were able to have an SPMC table at the South Carolina Numismatic Association show in Greenville, SC. We are now starting to discuss plans for the upcoming FUN Show in January. We hope to be able to have an SPMC table at that show as well.

Welcome to a new collecting year and I trust everyone had a nice holiday. I would like to thank the various Past Presidents and other contributors who helped to make our Nov-Dec 60th Anniversary Paper Money issue special by providing their memories of how the society has progressed throughout the years.

At the time of this writing, plans are in place for the SPMC to have a table at the Florida United Numismatist (FUN) show in January with several members volunteering to staff the table. At the show, the SPMC will also participate in the ANA's Treasure Trivia Program where children can stop by our table, find the answer to a trivia question about paper money, and then be given a small prize. The theme this year will be about why some banknotes have a star in their serial number. Speaking of star notes, I recently saw a Canadian Devil's Hair replacement star note \$1 bill come up at auction. Although I didn't bid on this one, I thought that would be an interesting item to own someday. A good friend of mine, Alan Bailey, bought a very nice one years ago and enjoyed showing it off after the purchase. I do have a few notes from countries other than the United States but it is a small group mostly consisting of special serial numbers, replacement notes, or another attribute that caught my eye.

I was recently looking at items for sale at an online bidding site and was surprised to see how many old Department of Agriculture food coupons "food stamps" were for sale. At one time, it was not legal to own food stamps unless one was entitled to be on the program. In 2009, food stamps were demonetized and are now available to collect. Since food stamps were printed at the Bureau of Engraving and Printing, had serial numbers just like currency, and they also produced replacement star issues, the collecting of food stamps was a natural draw for some collectors. One challenge was to find a good example that hadn't been torn out of the book but was fully intact. I recall being at many shows and seeing small groups of stealthy collectors sneaking around in the shadowed corners swapping items which I can neither confirm nor deny were food stamps. Today they are legal to own and collect and can readily be found online. I own only one food stamp so far, a \$5 star replacement. I rarely see them offered at numismatic shows; perhaps not enough of them were saved to create a widespread collector base. If you are interested, in the May/June 2011 Paper Money magazine, Peter Huntoon and Tom Conklin wrote a very informative article on the subject.

With the help of Governor Mark Drengson, the SPMC is working on the development of and sponsorship of a "Collecting Paper Money" wiki website. As the project proceeds, we will be seeking help from our membership to contribute to the content development. I have some great news for everyone. At our last board meeting, we confirmed our plans to hold the next SPMC annual meeting in conjunction with the upcoming FUN show in January 2023. Planning is underway and we expect to have our annual breakfast, a membership meeting, as well as exhibit grading and award presentations. You will find more information about it in this and future issues of Paper Money magazine.

In February, along with VP Robert Calderman, Nancy Purington and I had the opportunity to staff our SPMC Table at the Long Beach Exposition, The Collectibles Show. We had a great time and did sign up some new members and handed out several applications which hopefully will be submitted at a later date. Both Robert and I were able to locate a few new treasures for our collections at this show.

What turned out to be a somewhat humorous story was the "case of the counterfeit bill" inquiry. I was with a dealer at the show when a customer arrived and showed the dealer a well worn 1934 \$100 Light Green Seal FRN and asked if it was real or a counterfeit. The dealer examined the note and although the "paper" had a slick feel to it after having been either pressed or living in a wallet for years, decided it was in fact a real note. The dealer handed me the note and I examined it using a good magnifying glass and due to the sharpness of the print also agreed that it was a genuine note. The customer finally asked the dealer if he wanted to buy it from him for face value, so the dealer took out five \$20 bills and bought the note. The customer then stated that it was a good profit because he had only paid \$50 for the note from someone who thought it was a counterfeit. I have purchased postage stamps below face value before, but I have never been able to buy currency in that manner. We all got a laugh out of that one.

I was looking through the various and often entertaining posts on Facebook the other day and was interested to see there were several posts about the Web-fed press \$1 Federal Reserve Notes. It seems there is a renewed interest in those experimental notes. When the 1988A Series web notes started appearing, several of us became very interested in locating and assembling sets by issued districts, blocks, and plate combinations. Jim Hodgson and I compiled a list of the early printing figures of those notes that was subsequently used in the Standard Guide To Small-Size U.S. Paper Money 1928 To Date by John Schwartz and Scott Lindquist. Later, Bob Kvederas Jr. published a very comprehensive booklet on the subject covering all three series of the notes. I still have an extensive web-fed note collection. I haven't seen one show up in circulation, or as the Facebook crowd likes to say, "in the wild" for many years. To my knowledge, the very first F-star replacement web-fed note was discovered by my friend Alan Bailey while he and I were searching through packs of singles sitting in my car in Joliet, Illinois. He found two circulated star notes in one pack and was kind enough to give me one of them. We took the notes with us to the Memphis show that year and made quite a splash. At that time, nobody had ever seen one or knew of their existence.

On a closing note, I would like to thank SPMC member Peter Robin and his wife Renate for their kind donation of several years of past Paper Money magazines. I would also like to thank Past President Mark Anderson for arranging to pick up the donation.

A lot has happened in the world since our last issue of Paper Money magazine. I am sad to report the passing of our Past President, Larry D. Adams, who died in Granger, IA in October as the result of an automobile accident. Larry was the curator of the Higgins Museum of National Bank Notes. Larry collected business cards and did investigative work. He and I had a very nice conversation earlier this year. Our thoughts go out to his family.

Although expected, the passing of Queen Elizabeth II was sad for many people. I watched several parts of the service and as usual, the British people did a great job with the performance. The redesign of their currency and coins was being planned. I was surprised to learn that the way the portrait face changes from the King or Queen facing left or right during each new Therefore, we can expect the portrait of King Charles III to face toward the left on the new coins although I am not sure that same custom exists for currency since many banknotes show the Queen facing straight or to the left. On Jul 8, 1976, from the windows at the top of the Statue of Liberty, I saw Queen Elizabeth II and Prince Philip arriving in New York harbor on the Royal Yacht Britannia. We were delayed leaving Liberty Island until she had disembarked in New York. The Queen came for her second visit to NYC to collect the rent due her from the Trinity Church at Broadway and Wall Street. 279 peppercorns in a Steuben glass container were given to her for the 1 peppercorn per year rent from the agreement made with her ancestor King William III.

Speaking of redesigned currency, with the September signing of Chief Lynn Malerba as the new United States Treasurer, we too can expect new currency soon with an updated signature.

Hurricane Ian was certainly a big event for many of us. Fortunately, our home in Florida was not affected by the hurricane but many of my friends and family cannot say the same. I thought it was nice that Paper Money Guarantee (PMG) located in Sarasota provided hurricane updates on their website since many of their customers, including me, were concerned about their preparation and the protection of the no-doubt millions of dollars' worth of items previously submitted for grading. Fortunately, all turned out well for PMG although not so well for many of their close neighbors to the South.

As some of you may be aware, In September we rolled out the SPMC Paper Money Articles Index. The index provides online links to all 2500+ articles that have appeared in the Paper Money Journal since the first issue in 1962. However, one must be a member of the SPMC to access articles

printed in the last five years. If you haven't seen it yet, please log onto the SPMC.org site and check it out. Earlier this year, I was able to reacquire a black Fractional Currency Shield I once owned. I originally purchased the shield in 1992 from a dealer in West Chester, PA and am excited to own it again. After picking up the shield, I had it reframed (keeping the old original frame) with new acid-free backing and museum quality UV glass. When I opened up the frame for the work to be done, it was the first time I had ever had the opportunity to hold an unframed shield.


