OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 OR OLDER (EXCLUDING RESIDENTS OF PUERTO RICO, AND ALL OTHER U.S. TERRITORIES AND POSSESSIONS). VOID IN PUERTO RICO AND ALL OTHER U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED.

1) **ELIGIBILITY:** World Market's Spruce Up Your Space Sweepstakes (the "Promotion") is open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at the time of entry (excluding residents of Puerto Rico, and all other U.S. territories and possessions). Void in Puerto Rico and all other U.S. territories and possessions and where prohibited. Employees of Cost Plus, Inc. ("Sponsor"), Haley Miranda Group, Inc.
