
Online freelancing platform with job search and bidding capabilities integrated on smart contracts to provide a trustless experience to the users.



About the application

This application is an online freelancing platform that connects businesses and individuals with independent professionals from various fields. It serves as a marketplace where clients can post job listings or projects, and freelancers can bid on those opportunities to provide their services. Bidsyn provides a platform for remote work, allowing clients to access a global pool of talent and freelancers to find work opportunities regardless of their geographical location.

Scope of Work

Requestor: Requesters initiate the process by posting job listings or projects on Bidsyn. They provide details about the project requirements, scope, deliverables, budget, and timeline. Clients also review the proposals submitted by freelancers and evaluate their skills, experience, portfolios, and rates. They have the responsibility of selecting the most suitable freelancer(s) for their project. Requestors are responsible for making timely payments to freelancers for the work completed. Bidsyn provides payment processing services, allowing clients to securely pay freelancers through the platform.

Bidder: Bidders create a compelling and detailed freelancer profile that showcases their skills, experience, portfolio, and expertise. Highlighting their qualifications, certifications, and relevant work samples to attract clients. Bidders browse through job listings or projects posted by clients and submit proposals for the ones that align with their skills and interests. Then, Bidders execute the project tasks according to the agreed-upon scope, timeline, and quality standards. Meet project milestones and deliverables as per the client's requirements. If needed, provide progress reports, work samples, or prototypes to keep the client informed.

Administrator: The Admin user has full control of managing and maintaining the Upwork platform, ensuring its smooth operation and functionality. They handle technical aspects, platform updates, and security measures to provide a reliable and secure environment for clients and freelancers.

Backend Development

Frontend Development


Client required dedicated frontend interfaces for Requesters and Bidders as well as admin users.

Job posting



Once a job created and a bidder is hired on it, that job cannot be removed from the platform, in order to make the platform trustable and efficient.



Bidder search


Requesters can browse through the profiles of numerous bidders according to the requirement filters and find the right person for the job.





Offer functionality

Requesters can also send the offers to the bidders of their choice and reach an agreement for the jobs. Bidder can accept the offer or communicate with the requesters if negotiations are required.



Job Proposals functionality

Bidders can search the jobs posted on the platform and find work of their choice, bidders can also send the proposals to the requesters for job requests specifying their hourly/fixed rate and other relevant details.


