The Federal Surplus Property Program makes surplus property from federal government agencies (including the military) available to a variety of eligible organizations for 5-10% of the government's original acquisition cost.

The Program is funded entirely by service charges that are paid by participating organizations for items they acquire, and saves Texas organizations and taxpayers millions of dollars each year. The Program also encourages conservation through the reuse of valuable items that might otherwise end up in landfills.

City of Pflugerville converted this travel trailer into a mobile command center for the Police Department. The government's original purchase price was \$20,000 but the City paid FSP a service charge of only \$2,500!

City of Three Rivers acquired this truck for its fire department. The government's original purchase price was \$67,139 but the City paid FSP a service charge of only \$6,500!
