Written comments and suggestions from the public and affected agencies concerning the proposed collection of information are encouraged. Your comments should address one or more of the following four points:

- Evaluate whether the proposed collection of information is necessary for the proper performance of the functions of the agency, including whether the information will have practical utility;
- Evaluate the accuracy of the agency's estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions used;
- Enhance the quality, utility, and clarity of the information to be collected; and

- Minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses.

## Need for Collection:

The Safe Explosives Act requires an explosives distributor must verify the identity of the purchaser; an explosives purchaser must provide a copy of the license/permit to distributor prior

to the purchase of explosive materials; possessors of explosive materials must provide a list of

explosives storage locations; purchasers of explosive materials must provide a list of

representatives authorized to purchase on behalf of the distributor; and an explosive purchaser

must provide a statement of intended use for the explosives.

(5) An estimate of the total number of respondents and the amount of time estimated for an

average respondent to respond: There will be an estimated 50,000 respondents, who will

take 30 minutes to comply with the required information.

(6) An estimate of the total burden (in hours) associated with the collection: There are an

estimated 25,000 total burden hours associated with this collection.
