Agency Information Collection Activities: Application to Adjust Status from Temporary to Permanent Resident, Form Number I-698; Extension, Without Change, of a Currently Approved Collection.

Action: 30-Day Notice.

SUMMARY: The Department of Homeland Security (DHS), U.S. Citizenship and Immigration Services (USCIS) will be submitting the following information collection request to the Office of Management and Budget (OMB) for review and clearance in accordance with the Paperwork Reduction Act of 1995. The information collection notice was previously published in the <u>Federal Register</u> on October 4, 2012, at 77 FR 60708, allowing for a 60-day public comment period. USCIS did not receive any comments in connection with the 60-day notice.

DATES: The purpose of this notice is to allow an additional 30 days for public comments. Comments are encouraged and will be accepted until [Insert date 30 days from date of publication in the <u>Federal Register</u>]. This process is conducted in accordance with 5 CFR 1320.10.

Therefore, submitting this information makes it public. You may wish to consider limiting the amount of personal information that you provide in any voluntary submission you make to DHS. Written comments and suggestions from the public and affected agencies should address one or more of the following four points:

(1) Evaluate whether the proposed collection of information is necessary for the proper performance of the functions of the agency, including whether the information will have practical utility;

- (2) Evaluate the accuracy of the agencies estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions used;
- (3) Enhance the quality, utility, and clarity of the information to be collected; and
- (4) Minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses.

- (4) Affected public who will be asked or required to respond, as well as a brief abstract:

 Primary: Individuals or households. The data collected on this form is used by USCIS to determine eligibility to adjust an applicant's residence status.
- (5) An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond: 165 responses at 1 hour per response.

(6) An estimate of the total public burden (in hours) associated with the collection: 165 annual burden hours.
