### Endangered and Threatened Wildlife and Plants; Recovery Permit Applications

**AGENCY:** Fish and Wildlife Service, Interior.

**ACTION:** Notice of availability; request for comments.

**SUMMARY:** We, the U.S. Fish and Wildlife Service, invite the public to comment on the following applications to conduct certain activities with endangered or threatened species. With some exceptions, the Endangered Species Act of 1973, as amended (Act), prohibits activities with endangered and threatened species unless a Federal permit allows such activity. The Act requires that we invite public comment before issuing these permits.

## **SUPPLEMENTARY INFORMATION:**

### **Background**

The Act (16 U.S.C. 1531 *et seq.*) prohibits activities with endangered and threatened species unless a Federal permit allows such activity. Along with our implementing regulations at 50 CFR 17, the Act provides for permits and requires that we invite public comment before issuing these permits.

A permit granted by us under section 10(a)(1)(A) of the Act authorizes the permittees to conduct activities with U.S. endangered or threatened species for scientific purposes, enhancement of propagation or survival, or interstate commerce (the latter only in the event that it facilitates scientific purposes or enhancement of propagation or survival). Our regulations implementing section 10(a)(1)(A) for these permits are found at 50 CFR 17.22 for endangered wildlife species, 50 CFR 17.32 for threatened wildlife species, 50 CFR 17.62 for endangered plant species, and 50 CFR 17.72 for threatened plant species.

The applicant requests a permit to conduct presence/absence surveys for the southwestern willow flycatcher (*Empidonax traillii extimus*) in Arizona, New Mexico, Utah, and Colorado for the purpose of enhancing the species' survival.

The applicant requests a permit to conduct presence/absence surveys for the American burying beetle (*Nicrophorus americanus*), Hine's emerald dragonfly (*Somatochlora hineana*), Ozark hellbender (*Cryptobranchus allenganiensis bishopi*), Higgins eye pearl mussel (*Lampsilis higginsii*), winged mapleleaf mussel (*Quadrula fragosa*), Neosho mucket (*Lampsilis rafinesquenana*), pink mucket pearl mussel (*Lampsilis abrupta*), scaleshell mussel (*Leptodea leptodon*), sheepnose mussel (*Plethobasus cyphus*), snuffbox mussel (*Epioblasma triquetra*), Curtis' pearl mussel (*Epioblasma florentina curtisii*), fat pocketbook (*Potamilus capax*), Topeka shiner (*Notropis Topeka*), spectaclecase mussel (*Cumberlandia monodonta*), pallid sturgeon (*Scaphirhynchus albus*), Quachita rock pocketbook (*Arkansia wheeleri*) in Kansas, Arkansas, Oklahoma, Nebraska, Missouri, and Iowa for the purpose of enhancing the species' survival.

The applicant requests a permit to conduct presence/absence surveys for the Topeka shiner (*Notropis topeka*) in South Dakota for the purpose of enhancing the species' survival.
