**BE IT ENACTED:**

**SECTION ONE. AUTHORITY**

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A).
- B. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840(A).
- C. The Budget and Finance Committee has oversight of the Office of the Navajo Tax Commission. 12 N.N.C. § 301(B)(13).

**SECTION TWO. FINDINGS**

- A. The Budget and Finance Committee held a hearing and took budget testimony regarding the Office of the Navajo Tax Commission, Fiscal Year 2021 Budget. 12 N.N.C. § 840(A).
- B. The Budget and Finance Committee recommends a fiscal year budget for the Office of the Navajo Tax Commission. 12 N.N.C. § 840(A).

**SECTION THREE. APPROVALS AND RECOMMENDING THE PROPOSED FISCAL  
YEAR 2021 BUDGET FOR THE OFFICE OF THE NAVAJO TAX COMMISSION**


- A. The Budget and Finance Committee hereby recommends the proposed Navajo Nation Fiscal Year Budget for the Office of


