RECOMMENDING THE PROPOSED FISCAL YEAR 2021 BUDGET FOR THE
OFFICE OF MANAGEMENT AND BUDGET TO BE INCLUDED IN THE NAVAJO
NATION COMPREHENSIVE BUDGET FOR FISCAL YEAR 2021**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A).
- B. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840(A).
- C. The Budget and Finance Committee has oversight of the Office of the Management and Budget. 12 N.N.C. § 301(B)(13).

SECTION TWO. FINDINGS


- A. The Budget and Finance Committee held a hearing and took budget testimony regarding the Office of the Office of Management and Budget, Fiscal Year 2021 Budget. 12 N.N.C. § 840(A).
- B. The Budget and Finance Committee recommends a fiscal year budget for the Office of the Management and Budget. 12 N.N.C. § 840(A).

SECTION THREE. APPROVALS AND RECOMMENDING THE PROPOSED FISCAL YEAR 2021 BUDGET FOR THE OFFICE OF MANAGEMENT AND BUDGET

- A. The Budget and Finance Committee hereby recommends the proposed Navajo Nation Fiscal Year Budget for the Office of the Management and Budget, as provided on the Fund Type Budget Summary, attached as **Exhibit A**.
- B. The Budget and Finance Committee requests the changes to the Budget, as set forth in the General Fund Comparative Summary, **Exhibit B**, Recommended Changes to the General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**, be incorporated into the Navajo Nation Comprehensive Budget.


