This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.



17 SECTION ONE. AUTHORITY

- 18 A. The Law and Order Committee is a Standing Committee of the Navajo Nation
19 Council with authority to "review and make recommendations to the Navajo Nation
20 Council on proposed amendments to and enactments in the Navajo Nation Code." 2
21 N.N.C. §601(B)(14).
- 22 B. The Naa'bik'íyáti' Committee is a Standing Committee of the Navajo Nation Council,
23 2 N.N.C. § 700(A), and all proposed legislations requiring final action by the Navajo
24 Nation Council are assigned to the Committee. 2 N.N.C. § 164 (A)(9).
- 25 D. The Naa'bik'íyáti' Committee is specifically empowered as the oversight committee
26 for commissions under the Legislative Branch of the Navajo Nation, including the
27 Navajo-Hopi Land Commission. 2 N.N.C. § 701 (5).
- 28 C. The Navajo Nation Council is the governing body of the Navajo Nation with the
29 authority to enact positive law of the Navajo Nation. 2 N.N.C. § 102 (A) and 164 (A).

1 **SECTION TWO. FINDINGS**

- 2 A. The Navajo Nation Council established the Navajo-Hopi Land Commission within the
3 Legislative Branch as a commission of the Navajo Nation Council. 2 N.N.C. § 851 (A).
4 B. The Navajo-Hopi Land Commission Plan of Operations has not been comprehensively
5 updated since 1989.
6 C. The Navajo-Hopi Land Commission recommends that its Plan of Operation, codified
7 at 2 N.N.C. §§ 851-858, be amended as set forth in NHLCD-10-19, attached as
8 **Exhibit A.**

9
10 **SECTION THREE. AMENDING 2 N.N.C. §§ 851-858**

11 The Navajo Nation hereby amends Title 2, Chapter 3, Subchapter 11, Article 1 of the
12 Navajo Nation Code as follows:

20 **§ 851. Establishment; purposes**

- 21 A. The Navajo-Hopi Land Commission (“Commission”) is hereby established within
22 the Legislative Branch.
23 B. It is the purpose of the Commission to:
24 1. Monitor, collect, and update information on any and all land use ~~conflicts~~
25 issues between the Navajo Nation, and the Hopi Tribe, Southern Paiute Tribe
26 and any claimants in and to lands within the area described in the Act of June
27 14, 1934 (48 Stat. 960).
28 2. Initiate the acquisition, and ~~Speak~~ and act for the Navajo Nation with respect
29 to the land selection and land exchange provisions of P.L. 96-305.

- 1 3. Speak and act on behalf of the Navajo Nation and advocate at the local,
2 regional, and national levels on issues related to Navajo Partitioned Lands
3 (NPL), Hopi Partitioned Lands (HPL) (on behalf of Navajo families living on
4 HPL), Former Bennett Freeze Area (Navajo-Hopi land issues), Nahata Dziil,
5 lands acquired using P.L. 96-305, and the Southern Paiute Tribe.
6 4. Establish Rehabilitation Trust Fund and Escrow Fund program budget
7 policies.
8 5. Speak and act for the Navajo Nation on any and all matters relating to the
9 well-being of impacted communities.

10
11 **§ 852. Membership; selection; Chairperson and Vice-Chairperson; term of office;**
12 **ex-officio members**

13 A. The Commission shall consist of nine (9) regular voting members and two (2) ex-
14 officio members who shall be appointed by the Speaker of the Navajo Nation
15 Council with the approval of the Naabik'iyáti' Committee of the Navajo Nation
16 Council. ~~The Commission shall have the authority to establish subcommittees as~~
17 ~~deemed appropriate to provide advisory input from citizens, professionals, federal~~
18 ~~and other non-elected sources.~~

19 B. The Commission shall consist of:

20 1. Nine voting members of the Navajo Nation Council representing areas
21 affected by the Navajo-Hopi Land Dispute ~~from each of the following areas:~~

23 b. Nahata Dziil
24 c. Teesto, Whitecone
25 d. Coppermine, K'aibii'to, Tonalea, Bodaway/Gap
26 e. Tsah Bii Kin, Shonto

28 g. Cameron, Coalmine Canyon, Leupp, Tolani Lake
29 h. Hard Rock, Forest Lake, Pinon, Blck Mesa, Whippoorwill
30 i. Tachee/Blue Gap, Low Mountain

1 2. All members of the Commission shall be appointed by the Speaker of the
2 Navajo Nation Council and shall serve at the pleasure of the Naabik'iyáti'
3 Committee of the Navajo Nation Council.

4 3. ~~The Agency Superintendent, Bureau of Indian Affairs, of Tuba City Agency~~
5 ~~and Crownpoint Agency~~ Navajo Regional Director of the Bureau of Indian
6 Affairs, Office of Navajo-Hopi Land Commission Office, Office of
7 Legislative Counsel, Navajo Land Department and Navajo Nation tribal
8 employees, when called upon, shall provide technical assistance input to the
9 Commission.

10 C. The Chairperson and Vice-Chairperson of the Commission shall be selected by
11 the Commission.

12 D. Commission members shall serve a term of office coinciding with the term of
13 office of members of the Navajo Nation Council and until their successors are
14 appointed.

15 E. The President and Vice-President of the Navajo Nation shall serve as ex-officio
16 members of the Commission.

17
18 **§ 853. Powers**

19 A. General. The Commission shall have all powers necessary and proper to carry out the
20 purposes set forth in 2 N.N.C. § 851.

21 B. Enumerated Powers. The Commission is hereby authorized and directed:

22 1. To advise the President of the Navajo Nation concerning all matters relating
23 to land use conflicts between the Navajo Nation and the Hopi Tribe, and
24 any claimants in and to lands within the areas described in the Act of June
25 14, 1934 (48 Stat. 960).

26 2. To speak and act ~~for~~ on behalf of the Navajo Nation with respect to the land
27 selection and land exchange provisions of P.L. 96-305 by making such
28 selections and approving or disapproving any proposed exchanges, subject
29 to the limitations set forth in resolution CN-69-80.

- 1 3. Shall provide direction to and appoint two members to the Joint
2 Commission as specified in the Intergovernmental Compact between the
3 Navajo Nation and the Hopi Tribe.
- 4 4. Provide for the compensation of the Commission members for meeting
5 attendance per the rate set in the meeting policies.
- 6 5. To advise and meet with communities that are directly affected by the land
7 dispute between the Navajo Nation and the Hopi Tribe.
- 8 6. To act and speak on all matters and recommend legislation relating to
9 Navajo Partitioned Lands (NPL), Hopi Partitioned Lands (HPL) (on behalf
10 of Navajo families living on HPL), Former Bennett Freeze Area (Navajo-
11 Hopi land issues), Nahata Dziil, lands acquired using P.L. 96-305, and the
12 Southern Paiute Tribe.
- 13 7. Shall initiate and recommend grazing, homesite leasing, housing
14 development, rights-of-way and other land development policies and refer
15 to appropriate Standing Committees for approval.
- 16 8. Approve energy development and set rental rates on lands that were
17 converted to trust lands with respect to the land selection and land
18 exchange provisions of P.L. 96-305.
- 19 9. Develop policies and monitor the Rehabilitation Trust Fund and Escrow
20 funds.
- 21 10. To serve as the oversight commission for the functions of the Navajo-Hopi
22 Land Commission Office.
- 23 11. Negotiate and meet with Hopi Tribe and Southern Paiute Tribe on matters
24 under the Commission's authorities.
- 25 12. Navajo projects initiated by the Office of Navajo-Hopi Indian Relocation
26 will be transferred to the Commission upon the eventual phase out, if any,
27 of the Office.

28
29 **§ 854. Meetings**
30

1 Meetings shall be held on the first and third Thursday of each month or on the call of the
2 Chairperson of the Commission, the President of the Navajo Nation, or upon written
3 request of any five (5) members of the Commission. At any meeting, a quorum shall
4 consist of ~~six (6)~~ five (5) members.

6 **§ 855. Procedure**

7 ~~Until such time as the Navajo Nation Council adopts procedures and rules for the conduct~~
8 ~~of Commission business, the~~ The Commission is empowered to develop its own
9 procedure for the conduct of meetings, provided that all formal substantive action shall be
10 taken by written resolution duly certified by the presiding officers, or memorialized by
11 written memorandum setting forth the action taken and signed by the presiding officer
12 and filed with the ~~Central~~ Records Management Department of the Navajo Nation.
13 ~~Minutes~~ Journals shall be kept of all meetings and shall be officially recorded by the
14 Office of Legislative Services.

16 **§ 856. Staff**

- 17 A. There shall be a Navajo-Hopi Land Commission Office under the direction of the
18 President of the Navajo Nation. The President of the Navajo Nation shall appoint a
19 ~~staff assistant~~ an Executive Director who shall head the Land Commission Office
20 who shall serve at the pleasure of the President of the Navajo Nation.
21 B. The Commission shall utilize the Navajo-Hopi Land Commission Office in
22 performing its assigned functions.

24 **§ 857. Reports**

25 The Commission shall report quarterly and in writing to the Navajo Nation Council
26 concerning matters relating to the land use conflict and agreements with the Hopi Tribe.

27
28 **§ 858. Subcommittees**

29 The Commission is authorized ~~and directed to establish at least one Citizen's Advisory~~
30 ~~Subcommittee to provide advice and assistance to the Commission. The members of the~~

1 ~~Citizen's Advisory Committee shall be non-elected private citizens who reside in or near~~
2 ~~the lands affected by P.L. 96-305 and such other private citizens as the Commission and~~
3 ~~the President of the Navajo Nation may deem appropriate. to establish subcommittees as~~
4 ~~deemed appropriate to provide advisory input from citizens, professionals, federal and~~
5 ~~other non-elected sources.~~

7 **SECTION FOUR. EFFECTIVE DATE**

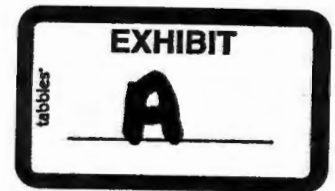
8 This action of the Navajo Nation Council herein shall be effective pursuant to 2 N.N.C. §
9 221(B). Further, the "President's authority to sign into law or veto legislation shall be
10 deemed waived if not exercised within ten calendar days after certification of the
11 legislation by the Speaker or Speaker Pro Tem and the legislation shall be deemed
12 enacted and become effective pursuant to 2 N.N.C. §221." 2 N.N.C. § 1005(C)(12).

13
14 **SECTION FIVE. CODIFICATION**

15 The provisions of these amendments of the Navajo Nation Code shall be codified by the
16 Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such
17 amendments in the next codification of the Navajo Nation Code.

18
19 **SECTION SIX. SAVINGS CLAUSE**

20 Should any provision of these amendments be determined invalid by the Navajo Nation
21 Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo
22 Nation Supreme Court, those amendments that are not determined invalid shall remain
23 the law of the Nation.

 2. Speak and act for the Navajo Nation with respect to the land selection and land exchange provisions of P.L. 96-305. 2 N.N.C. §851(B)(2)


- A. The Plan of Operation for the Navajo-Hopi Land Commission was last generally updated on December 15, 1989. CD -68-89
- B. The amendments to the Navajo-Hopi Land Commission is in the best interest of the families impacted by the Navajo and Hopi Indian Land Settlement Act and the Navajo-Hopi Indian Relocation Amendment Act of 1980, Public Law 96-305.



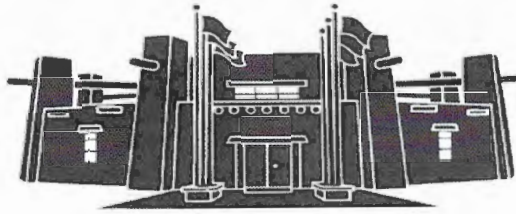

I have prepared the above-referenced proposed resolution and associated legislative summary sheet pursuant to your request for legislative drafting. Based on existing law and review of documents submitted, the resolution as drafted is legally sufficient. As with any action of government however, it can be subject to review by the courts in the event of proper challenge.

The Office of Legislative Counsel confirms the appropriate standing committee(s) based on the standing committees powers outlined in 2 N.N.C. §§301, 401, 501, 601 and 701. Nevertheless, "the Speaker of the Navajo Nation Council shall introduce [the proposed resolution] into the legislative process by assigning it to the respective oversight committee(s) of the Navajo Nation Council having authority over the matters for proper consideration." 2 N.N.C. §164(A)(5).

Please ensure that his particular resolution request is precisely what you want. You are encouraged to review the proposed resolution to ensure that it is drafted to your satisfaction.


