19 **Section One. Authority**

- 20 A. The Budget and Finance Committee is established as a standing committee of the  
21 Navajo Nation Council. 12 N.N.C. § 300(A).  
22 B. The Budget and Finance Committee is empowered to exercise oversight authority  
23 including but not limited to budget, finance, investment, contracting, and audits in  
24 order to coordinate, oversee, and regulate the fiscal, financial, investment,  
25 contracting, and audit polices of the Navajo Nation. 12 N.N.C. § 300(C)(1).

27 **Section Two. Findings**

- 28 A. The Navajo Nation acknowledges the United States Department of Interior Office  
29 of the Special Trustee for American Indians (the "Office of the Special Trustee")  
30

1 requires the designation of tribal officials to conduct financial business with the  
2 Office of the Special Trustee.

- 3 B. The Navajo Nation Office of the Controller has submitted a revised designation form  
4 in the document, "Tribal Officials Authorized to Initiate Disbursements and Receive  
5 Information on Tribal Accounts," attached as **Exhibit A**. The Department of Justice  
6 has reviewed the revised designation form and determined it to be legally sufficient.  
7 The Department of Justice review is attached as **Exhibit B**.
- 8 C. The prior designation of tribal officials authorized to conduct business in BFMY-08-  
9 16 shall be replaced with the updated authorization form in **Exhibit A**.

11 **Section Three. Approval**

12 The Navajo Nation hereby authorizes the designation by the Navajo Nation Office of  
13 the Controller, as set forth in the attached **Exhibit A**, to conduct business with the  
14 Office of the Special Trustee, including but not limited to requests for tribal  
15 disbursements and fund drawdowns.

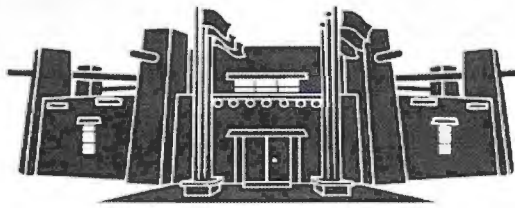


