REGIONAL MAP

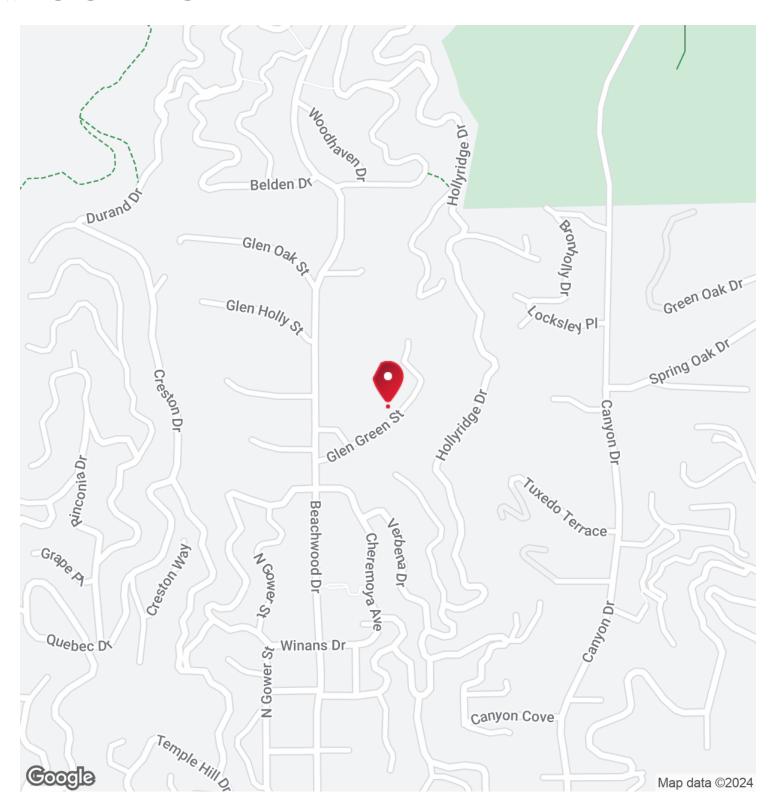

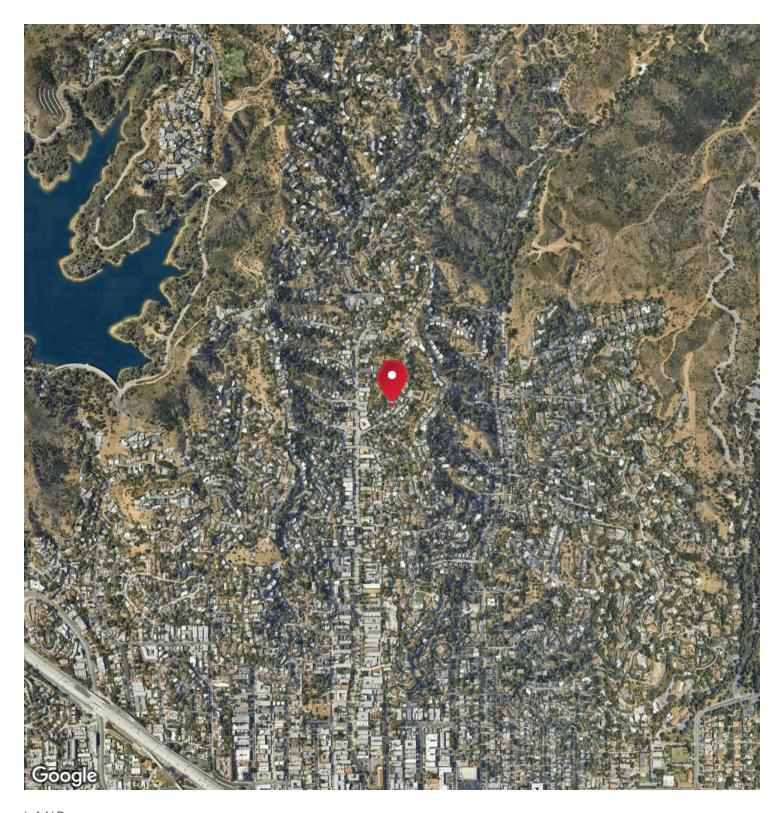
LOCATION MAP

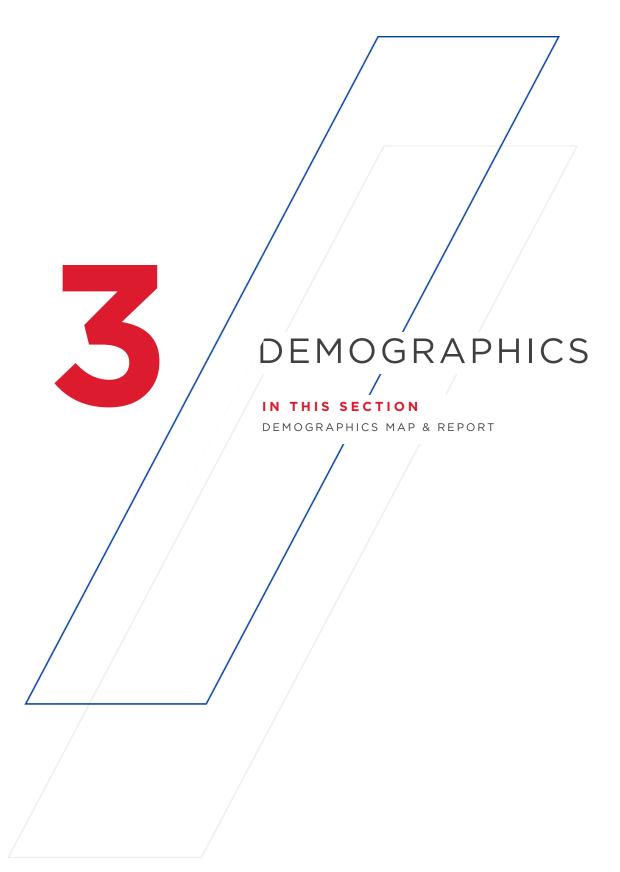

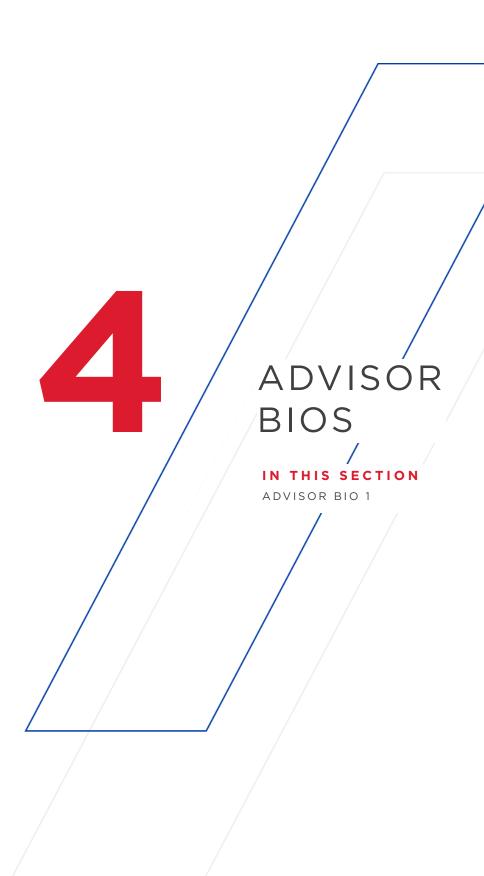
