Overall: C

Overall Grade

A = 10 Years or more of service life remaining
B = 8-10 Years of service life remaining
C = 5-7 Years of service life remaining
D = 2-4 Years of service life remaining

F = Less than 1 Year of service life remaining

Recommendations

Several deficiencies are affecting the Overall Grade of the current roof system.

The below repairs can be out the Overall Grade to (A) 10 Yrs, or more carviscable life.

The below repairs can boost the Overall Grade to (A) 10 Yrs. or more serviceable life remaining.

- (a) Approx. 20 LF of wall flashing were found loose and unsecured from the current termination bar in place allowing areas for the elements to gain entry under the roof system.
 - Install termination bar securing the membrane to the parapet wall.
- (b) The sealants across all 120LF of the current termination bar have deteriorated, cracked, or has begun to peel from the brick parapet walls and is susceptible to the elements.
 - -Complete 3 coarse repairs to the entire 120 LF of wall termination.
- (c) Other base flashings were found loose and susceptible to the elements.
 - Complete 3 coarse repairs to prolong service life of the roof system.
- (d) Clogged Drainage. Drainage is an important and often over looked part of a roof system.
 - Remove debris from the roof top and from within gutter system.

Description

- (a) Install 20 LF of termination bar securing the membrane to the parapet wall.
- (b) Complete 3 coarse repairs to the entire 120 LF of wall termination bar.
- (c) Base Flashings, complete 3 coarse repairs. Approx. 12LF
- (d) Remove debris from the roof top and from within gutter system.
