

Parent Statement of understanding and waiver of liability

The following information is important for the safety and protection of your child. Please read the information, sign this form, and return it to the YMCA Child Care. This is a legal document and by signing it, you will be affecting your legal rights as well as the legal rights of your child.

Please keep and refer to your copy of the YMCA Child Care Parent Handbook. Your signature below indicates that you have received the handbook and agree to abide by all policies and procedures explained in this book.

I understand that the YMCA Child Care staff and volunteers are not allowed to babysit or transport children at any time outside of the YMCA programs unless approved by the Child Care Director and YMCA CEO. The YMCA will take immediate disciplinary action toward staff and volunteers if a violation is discovered.

I understand that I am not to leave my child at the YMCA or program site unless a YMCA Child Care staff member is there to receive and supervise my child.

I understand that my child will not be allowed to leave the program with an unauthorized person. Any person authorized to pick-up my child must be listed with the YMCA Child Care or other arrangements must be made in advance, in writing to the YMCA Child Care office to inform them of a change. I understand that the YMCA Child Care does not accept oral phone releases for an unauthorized person to pick-up my child.

I understand that should a person arrive to pick-up my child who appears to be under the influence of alcohol or drugs, staff may have no recourse but to contact the police for your child's safety. Please do not put staff in the position where they have to make this judgment call.

I understand that state law mandates the YMCA Child Care to report any suspected cases of child abuse or neglect to the appropriate authorities for investigation.

I understand that for my child to go outdoors, I will supply the sun screen in the original container with my child's name on the bottle and will give it directly to a staff member. By signing below I am giving consent for sun screen to be applied to my child by Child Care staff.

I understand that if my child needs diaper cream, chapstick, lotion, special hand soap, or hand sanitizer, I will supply with my child's name on it in the original container and give directly to a Child Care staff person. I give the staff permission to apply as needed.

I understand that when my child is participating in the YMCA programs other than Child Care (swim lessons, gymnastics, etc) the YMCA Child Care and staff is not responsible for my child during those times.

Your child's growth and development is measured with Ages and Stages, a developmental screening and Ounce or Work Sampling, an assessment. If your child currently has an IEP/IFSP, it would be beneficial to share a copy of this plan with us, so we can work together to ensure that the guidelines are put into practice.

If it is determined that there is a possible need for an evaluation, the appropriate action will be discussed at a parent/teacher conference. The Child Care Director/Site Supervisor will refer you to the appropriate community agency. The YMCA Child Care will partner with the agency through use of our facility and program to provide service to your child and family.

If my child leaves the YMCA Child Care program, per my request a copy of his/her records will be transferred to the facility of my choice.
