

TERMS AND CONDITIONS FOR PARTICIPATION IN THE TCS NEW YORK CITY MARATHON on November 1<sup>st</sup>, 2020 with Team Reeve®

Team Reeve NYC Minimum Fundraising Requirement before drawing \$4,000, Minimum Fundraising Requirement after drawing \$4,000, Fundraising deadline: October 31<sup>st</sup>, 2020.

In the event you do not meet the minimum fundraising requirement by the date outlined above, the Christopher & Dana Reeve Foundation will charge the balance owed to your credit card. We accept Visa, MasterCard, American Express and Discover. Credit cards will not be charged if fundraising minimum is met.

Registration: Upon being accepted into the Team Reeve program, participant will complete 1. Credit card transaction form, 2. Set up custom Team Reeve fundraising page, 3. Complete NYRR marathon registration link to be provided from Team Reeve manager. Participant will be provided with any and all pertinent information to complete these steps in a timely manner.

Cancellation Policy: After official acceptance on the 2020 TEAM, you will be responsible for raising the stated minimum for the chosen event even if you choose to cancel your participation for ANY reason. Any donations received by the Christopher & Dana Reeve Foundation/Team Reeve will not be returned. Please note, we cannot defer your guaranteed entry to the following year. This is not a Christopher & Dana Reeve Foundation policy, but rather a New York Road Runners policy. If for any reason you are not able to participate, but reach your fundraising minimum, you may apply to be considered for the team in 2021.

Matching Gift Policy: Many companies match employee charitable contributions. Please check with your employer to see if your company participates in this program and ask your donors to see if their employers match as well. If you plan to use a match to reach your minimum, you should contact the matching company to ensure the check or wire transfer will be issued prior to the marathon/race date, and alert Team Reeve staff if this is not the case. You will be asked to provide information on the matching gift including; amount, date given, name of donor, and name of matching company.

Release Form and Contribution Agreement: In consideration of my accepting this entry, I hereby for myself, heirs, executors and administrators, waive and release any and all rights and claims for damages I may have against the Christopher & Dana Reeve Foundation, Team Reeve, On Your Mark Productions, Inc. and sponsors for any, and all injuries suffered by me in said event. I further attest and certify that I am physically fit, will sufficiently train for competition in this event, and a licensed medical doctor has verified my physical condition. I also grant permission for use of my name and/or photograph or voice in broadcast, telecast, print or any other account of this event.

If accepted on the marathon team I agree to collect the required fundraising minimum for the Christopher & Dana Reeve Foundation by deadline of October 31<sup>st</sup>, 2020. If I have not reached the minimum in sponsorship by that date, I will be personally responsible for the balance owed and will ensure my credit card information provided is current and active to charge the remaining balance.
