# EITI Implementation

Gabon lost its status as 'EITI Candidate' on 27 February 2013, and is no longer recognised as an EITI implementing country.

The country submitted its second validation report? to the EITI Board on 15 February 2013, nine weeks after the deadline. The MSG? had refused to adopt the final validation? report drafted by validator Hart and decided not to submit a report at the 9 December 2012 deadline. The most recent EITI report? (covering 2009 and 2010) was published in early October 2012. The report covering 2007 and 2008 was published on 28 October 2012.

### Validation

Gabon completed Validation? on 7 September 2010, including publishing a final Validation report.

On 9 June 2011, the Board decided to renew Gabon's Candidate status and to require another Validation by 9 December 2012.

The Interest Group refused to sign off on the final validation report drafted by the Hart Group. It chose not to publish a report at the 9 December 2012 deadline. The Group has summarised its objections to

the report in a document on 11 December 2012. It submitted an adopted final report to the EITI Board on 15 February 2013, nine weeks after the deadline.
