### Academic Responsibilities Central Methodist College

- Catalogue Review: Catalogue review and revision was done every two to three years on all programs. I was responsible for writing and reviewing the sections on Ethics, Philosophy, Religion and Honors prior to printing.
- Each student graduating from the social science division was required to submit a 20-30-page paper for review by three faculty members, two in the department and one outside the department. I was chosen by the students to read on issues involving ethics and minorities. I sat in review on approximately 30 papers.
- I assisted in the development of the Honors web site.
- I developed a pamphlet and recruiting materials for the Honors program.
- I developed a pamphlet and recruiting materials for the Ethics major.
- I assisted in the development of a college relationship with Arthur Smith. The relationship involved discussions on Spirituality, Voodoo, Santeria and Native American belief systems. The mentorship of this relationship also involved the college-gifting program.

# College Service Central Methodist College

a) Philosophy/Religion Department 1990-03

Administrative Duties

<u>Recruiting Students</u>: I traveled to areas around the state to meet with students and parents, did phone interviews with prospective students, did on campus recruiting days to meet with parents and students, worked on scholarship competition/evaluation, assigned scholarships for both philosophy and religion and monitored scholarship students during matriculation.

<u>Parent's Day</u>: I met and discussed student progress with parents and developed the department display.

<u>Work-Study/Department Fellow</u>: I was involved in the selection of students, the assignment of duties and times. I assisted in the supervision and development of tutoring sessions and signed time sheets.

Religious Certification Program: I assisted in the development and establishment of a program for students who wished to be certified in the areas of Church/Religious Music, Sunday School Education, Lay Speaking and Religious Education. I assisted in the implementation of the program and some teaching.

<u>Vogt Prize</u>: Each year students submitted papers in philosophy to be reviewed. I reviewed the papers and helped to choose the paper for the award. The paper requirements involved advanced and significant philosophical understanding as well as superior writing skills.

Outstanding Senior Religion Student Award and Swachammer Award for the Student Showing Most Promise in Ministry: I assisted two other professors in the evaluation and assignment of these awards.

Student Advisor: I developed degree plans and monitored the progress of the students during matriculation. I was assigned first year students, transfers, double majors and students changing majors. Advisors calculated majors and minors as well as college requirements and the character and diversity core. Degree plans were submitted in the junior year for approval by the registrar in order for a student to qualify for graduation. Advisors kept portfolios on each student and reviewed each student yearly.

<u>Freshman Religion Component</u>: All students were required to pass Introduction to Religion. I was one of three professors that administered this course. We designed and implemented the course based on the college requirements for character and diversity. I administered and scored the pre- and post-exam on religion in order to evaluate the students.

Senior Evaluation for Graduation: Each department was required to give a senior comprehensive test, both written and oral, in order for the student to apply for graduation. I administered the philosophy exams from 1993-2003 and assisted in the oral religion exams.

<u>Post-Graduation Placement</u>: I assisted in the on-campus visits made by seminaries and post-graduate programs. I assisted students in filling out applications and in the development of portfolios. Student placement included Duke, Boston University, University of Missouri-Columbia and Fordham.

<u>Program Review</u>: In 2001-02, I was involved in the departmental program review. The department was required to review students, courses and degrees. I was responsible for gathering statistical information on the courses and students in my areas of the department. The review also required the evaluation of departmental faculty. I was involved in the presentation of the review to the college review board and in the revision of the department based on the results of the review.

<u>Yearly Program Review</u>: Beginning in 2000, a yearly departmental and student review was put in place.

### Teaching Duties

I was the person in the department responsible for teaching both religion and philosophy courses from introductory courses to graduate courses.

### b) Honors Program 1993-03

#### Administrative Duties

Research and Development: I researched honors and gifted programs as well as both honors and gifted students and developed a unique honors program based on a model involving student design and implementation of courses. I recommended the proposal design to the honors committee and later to the faculty academic affairs committee. After gaining the final approval from the faculty, I was able to implement the new program in three months.

<u>Recruiting</u>: I was responsible for recruiting students, both on-campus and prospective. I developed pamphlets and materials to introduce the uniqueness of the program to students and high school guidance counselors and worked with department and division heads to encourage student participation. I participated in scholarship

competitions and gave speeches to introduce the honors program to high school juniors and seniors. I interviewed and selected students for scholarships and monitored the matriculation of all honors scholarship students.

<u>Parent's Day</u>: I represented the honors program to both parents and students and answered questions. I designed all display materials.

<u>Work-Study</u>: I interviewed and chose the work-study students, supervised their work and signed time cards.

Student Advisor: I was honors faculty advisor to all honors students and worked in conjunction with the primary advisor to develop degree plans. I was responsible for the degree plan in the areas involving honor and honors requirements for graduation.

Senior Thesis: I supervised all senior honors theses, which consisted of a 30-60-page paper in their major area of study. I was the primary or secondary reader on all honors papers. Both readers were required to supervise three drafts of the paper followed by the final draft, which was distributed to the honors committee for defense and approval. I organized and ran the defenses and chaired the meeting following the defenses to determine whether or not the students passed. Students who passed graduated from Central Methodist College with Honors. I presented cords to students who passed.

Graduation Ceremony: Students Graduating with Honors from CMC were presented to the Curators, the President, the Vice-President of the College, the Honors Committee and to their parents at a ceremony following Baccalaureate and before the Commencement Ceremony. I was tasked with the organization and the facilitation of the ceremony. I hosted and presented the students at the gathering.

<u>Post-Graduate Placement</u>: I worked with students researching post-graduate programs. I also worked with students studying for the LSAT and GRE to improve scores. I established a program to help students design portfolios and craft admissions statements/applications for medical schools, law schools and graduate schools across the country.

<u>Program Review</u>: In 2000-01, I was tasked with the review of the honors program. I researched and compiled data on the program and on the placement of students. I authored the report and submitted it to the honors committee for approval. I submitted the finalized report to the college review committee, defended the program and implemented the changes to the program based on the results

<u>Yearly Program Review</u>: Beginning in 2000, both the students and the program were reviewed by the honors committee on a yearly basis.

Teaching Duties

I developed and implemented all honors courses and was responsible setting up guest speakers.

Additional Honors Director Responsibilities

<u>Chair Honors Committee</u>: I was charged with setting the agenda and running the meetings, voting in cases of a tie, recording the minutes, and storing all information particularly sensitive materials involving student grade averages and student information. Yearly reports were filed in the office of the Vice-President and President of the college. I conferred with the President of the college on matters that required approval from the College Board of Curators.

<u>Commencement Program</u>: I wrote and reviewed the honors pages in the commencement program for both students graduating with honors and the honors awards presented at convocation.

<u>Graduation with Honors</u>: In conjunction with the registrar, I determined borderline statistical cases for graduation with Summa Cum Laude, Magna Cum Laude and Cum Laude both at the main campus site and the off campus site.

<u>Honors Cords</u>: I developed and implemented a system, in conjunction with the President of the college and the Vice-President of Academics, for the assignment and distribution of academic cords.

Common Reading: I instigated nominations for the yearly campus-wide common reading, which was to be touched on in every class and used in freshman orientation classes as well as in the senior capstone courses. I presented the committee choice at faculty meeting and negotiated book orders with the campus bookstore.

College Honorary Degrees: I instigated nominations for honorary degrees, established files of information on each person nominated, met with the President and Vice-President of the college to gain nominations from the Board of Curators, determined with the committee the nature of the honorary degree, submitted the results of the honors committee vote to the faculty, destroyed all of the information in the files and the information that had been distributed at the faculty meeting to insure the privacy of all nominees, submitted the faculty vote to the President for presentation to the Board of Curators and kept a running list of honorees. I was tasked with the establishment of housing and the welcome packets for the honorees.

<u>Faculty Meetings</u>: I gave the needed honors program reports at faculty meetings, presented issues for faculty vote, distributed conclusions of the faculty vote to Vice-President, President and Curators as indicated by the issue.

<u>Publicity</u>: I submitted the necessary honors information to the college PR office as well as to the local newspapers, radio and television organizations.

Alpha Lambda Delta Freshman Honors Society: I was faculty advisor and developed the lists of eligible students for the organization. I invited the students to join, collected the dues, organized the dinner/initiation, presided over dinner/initiation and submitted the end of year reports to the national office. After 1996, I eliminated the dinner placing the initiation on Honors Day prior to Honors Convocation.

Omicron Delta Kappa: In 1996-98, I was faculty advisor and helped to set up the banquet/initiation with parents and faculty.

Alpha Chi National Honors Society: I researched and instigated the process to get Alpha Chi on campus. I succeeded in gaining a charter and organized the instillation ceremony with national office. The national office sent a board member to install the chapter in a ceremony with the Vice-President and President of the College. I organized and ran subsequent initiations of students, established the campus criteria for Alpha Chi in relation to the honors courses and monitored student eligibility. I filed yearly reports with national office.

College Day of Excellence: From 1993-96 the Day of Excellence program was designed to recognize students in the areas of academics, service and talent. I compiled the list of eligible students and presented it to the honors committee for approval. I sent invitations to students and parents; organized a banquet for students, parents, faculty, administration and curators; and dealt with the ordering of food, table accessories, programs, flowers and the organization of head table. I chose and invited the guest speaker, hosted the ceremony and submitted the final accounts, names and reports to the Vice-President of Academics. I rolled this program into the Honors Day ceremonies beginning in 1996 and completely phased out the recognition of these groups in 1998 with the approval of the honors committee and the administration.

Honors Convocation 1993-1996: Honors Convocation was held on a Thursday in April for one hour. I collected the lists of students to be honored from department and division chairs, student affairs and the administration. I invited students and faculty, arranged the presenters and established the invocation. I designed and supervised the printing of the program. I supervised the building, air conditioning, lighting, sound and maintenance. I introduced the department and division heads involved in the presentation of the awards, presented the college awards, concluded the program and filed the needed reports with the administration. In 1996, I ended this program and established an Honors Day to be held on a Sunday in April. The establishment of the Honors Day allowed all honors events to be held on a single day when families could be involved.

Honors Day Convocation 1996-03: I established a day beginning with initiation into Alpha Lambda Delta and ending with the spring choir concert. I collected the names of students to be honored across all campus programs as well as by student affairs and the administration. I hired the designer for the invitations and the programs and approved the design. I sent invitations to students and families, organized the presenters and set the agenda for presentation. I organized the organist and speakers. I made arrangements for the equipment and the flowers. I was MC and introduced presenters, presented college

awards, academic affairs awards and scholarships. Beginning in 2000, I negotiated with the administration to take over the cost of convocation.

Honors Reception 1997-03: After Convocation the college had a reception for all involved. I ordered flowers, food and drink, organized the servers and hosted the reception. Beginning in 2000, I negotiated with the administration to eliminate the cost of the reception from the Honors budget.

# c) Ethics Program 1996-03

#### Administrative Duties

Research and Development: From 1994-96, I researched ethics institutes and ethics programs involving colleges and universities. I met with department heads and division chairs to discuss the program design in the areas of business/accounting ethics, bio/medical ethics, criminal justice/law ethics and research/psychology ethics. I contacted law schools and medical schools to pole faculty as to what they looked for in students. I developed the program to double as well as single major students in order to gain the best post-graduation placement. The program was also designed to address issues of race, class and gender in order to add diversity and depth of research to the program. I submitted the program design to the faculty academic affairs committee and to the faculty for approval. After gaining approval, the program was implemented the next semester.

Recruiting: I established a pamphlet and data for campus recruiters. I recruited ethics majors during recruitment days and scholarship contests and did phone interviews for placement. I was responsible for the assignment of all scholarship money and the matriculation of all scholarship students.

<u>Parent's Day</u>: I was responsible for all materials and displays. I met with students and parents about student progress.

Student Advisor: I was faculty advisor to all single major ethics students and faculty co-advisor for double-majored ethics students. I established portfolios of work including papers and tests for each student, evaluated student portfolios yearly and developed degree plans for both B.A. and B.S. programs.

<u>Senior Evaluation</u>: I developed and administered the senior written and oral test for graduation.

<u>Post-Graduate Placement</u>: I assisted students in application and portfolio development, assisted students in finding and researching programs. Student placement included post-graduate programs at Duke, Boston University, Harvard, Vanderbilt, University of Arkansas and University of Missouri.

<u>Program Review</u>: In 2001-02, I participated in a review of the ethics program. I compiled the data needed for review and wrote the documents. I submitted the information to the college review committee and implemented the revisions.

<u>Yearly Program Review</u>: Beginning in 2000, I implemented a yearly review of the ethics program.

### Teaching duties

I was responsible for development, implementation and evaluation of all ethics courses with the exception of one section of introduction to ethics.

### d) Institutional Review Board 1997-03

#### Administrative Duties

<u>Development</u>: The administration appointed a committee to establish and implement IRB regulations and requirements. These regulations and requirements were to be followed by all students and faculty in human/animal/environmental research.

<u>Duties</u>: I was tasked with the research and presentation of the ethical arguments involved in each case presented to the board. I was also appointed to be animal and environmental spokesperson. I was appointed to secure all documents involved. The board reviewed an average of ten cases a year.

# Senior Honors Theses Supervised

Honors papers were required to be 30-60 pages in length, with most averaging 50-60 pages. The students were required to submit four drafts to be edited by the primary and secondary readers. #### Central Methodist College

- <u>Aesthetics</u>: This course was designed to look at the philosophical foundations of aesthetics. The course used historical and contemporary works of art, music and architecture to evaluate and understand the theories.
- <u>Epistemology</u>: This course examined historical and contemporary readings in epistemology. The course also examined alternative theories of epistemology involving various cultures.
- <u>Critical Thinking K-12</u>: This course was designed as an undergraduate course to assist education majors in understanding and teaching critical thinking. The course also studied a system of teaching philosophy to K-12 established in Montclair New Jersey.
- Existentialism and Non-Realism in the Theatre: This course was co-designed and teamtaught with John Kelly, Associate Professor of Theatre and Communication. It examined plays involving non-realism and existentialism.
- <u>Philosophy of Science:</u> This course examined the philosophical foundations of scientific theories, both classical and contemporary. The course was team taught with one of the biology faculty for two semesters and put together both science and philosophy students. The course was later split into separate sections.
- Philosophy & Ethics of Business & Law, Bio-Medical Ethics, Environmental Ethics: These courses were designed for those students wishing to double major for professional and educational advancement.
- Women's Philosophy and Women Philosophers: This course was designed to address the need for diversity and comprehension in philosophy and ethics. The course focused on historical and contemporary women philosophers as well as historical and contemporary movements.
- <u>Women in Religion</u>: This course was designed to address diversity and comprehension in the study of world religions. The course examined sacred passages from world religions pertaining to women, the contribution of women to world religions, goddess religions and current patterns involving women and religion.
- <u>Capstone Course</u>: This was a team-taught course involving ethics and was required of all students for graduation.
- <u>Philosophy of Sex, Love & Marriage</u>: This course was designed to examine historical and contemporary philosophical ideas of love, sex and marriage.

- <u>History and Philosophy of Education</u>: This course was designed as a graduate course dealing with the philosophical and historical theories in education. The course focused on foundational, Marxist and critical theories of education. The emphasis of the course was to introduce students in the Masters of Education program to issues of race, class, gender and sexuality through the study of critical theorists.
- <u>Critical Thinking K-12</u>: This course was designed as a graduate course to assist those students in the Masters of Education program to understand the logical foundations and the implementation of critical thinking theories in the classroom. This course was designed to further the study begun in the undergraduate course by the same title.
- On-line Courses: Both History and Philosophy of Education and Critical Thinking K-12 were developed and taught on-line for the Masters of Education program.

Special Needs Courses Designed at Central Methodist College

- In 2001, I modified the Philosophy of Religion course at CMC to meet the needs of a quadriplegic student who used a computer for both speech and papers.
- In 1999, I developed an Introduction to Logic course at MU for a student who had suffered a brain injury.
