

SECTION A STUDENT ACKNOWLEDGEMENTS – COMPLIANCE AGREEMENTS POLICY REGULATIONS

I hereby accept the aid awarded me by the Columbus State University Schwob School of Music for the 2016-2017 academic year (Fall and Spring Semesters). I have read my award letter, and I agree to the conditions of this award. Specifically, I understand that:

- 1. My entire record will be subject to review each semester.
 - a. I must maintain enrollment as a music major with a minimum of twelve (12) credit hours successfully completed each semester.
 - I understand that I am expected to follow the SUGGESTED COURSE OF STUDY and other policies outlined in the HANDBOOK FOR MUSIC MAJORS and in order to graduate in eight (8) semesters, I must enroll in and successfully complete an average of 15 credit hours per semester.
 - b. I must receive a grade of B or higher in the major applied area each semester.
 - c. I must maintain a cumulative grade point average (GPA) of 3.0 in all music courses and a cumulative grade point average (GPA) of 2.5 in all course work.

- d. I understand that I must be enrolled in the appropriate performing activities (singers: Vocal Ensemble Activities; wind, brass, percussion: Wind Ensemble Activities; strings: Orchestral Ensemble Activities) each semester and must participate in any performing ensemble as deemed necessary by the School of Music. Continuing performance as an exemplary member of each organization and ensemble in which enrolled is an invariable condition of this contract.
- 2. If requested by the Director of the School of Music, scholarship students will provide reasonable services as a soloist or member of an ensemble for community and/or university event.
- 3. If the recipient student should qualify for grants and scholarship aid in excess of the total cost of tuition, fees, on-campus housing, meal stipend, the Schwob School of Music reserves the right to adjust the amount of this scholarship contract.
- 4. Students who withdraw from Columbus State University are subject to the institution's refund policy.

In accepting this offer of financial aid from Columbus State University, I understand that there is a mutual commitment on the part of myself and the institution. Therefore, I agree that after May 1 of the calendar year of matriculation into an undergraduate-level program or after April 15 of the calendar year of matriculation into a graduate-level program, I will not consider any other offer of financial aid from an institutional member of the National Association of Schools of Music or any other institution for the purpose of enrolling in a music major program for the academic year 2017-2018 except with the express written consent of the Director of the Schwob School of Music.
