Disadaptations: Adapting Disability from Page to Screen. Under contract with Edinburgh University Press.

When disability studies scholars address adaptations, they generally treat adaptation as a neutral process, neither additive nor reductive. *Disadaptations* argues adaptations of disability require an interdisciplinary approach that brings together disability studies and adaptation studies rather than the customary monodisciplinary or multidisciplinary approaches that produce these problematic neutral approaches. For example, disability studies research often calls out ableist Hollywood practices, such as casting able-bodied actors as characters with disabilities, adopting disability as visual shorthand for evil characters, or using disabled characters to comment upon the courage of disabled people. Tom Hanks as Forrest Gump and the long line of able-bodied actresses selected to portray Helen Keller in The Miracle Worker on both stage and screen exemplify these cinematic conventions. However, these readings presuppose adaptation's objectivity; nowhere does this conversation discuss the processes of adapting Gump and Keller from page to screen. As a result, disability studies scholars may ignore how Hanks's embodiment of Gump relates to characterization in Groom's novel or what's at stake in translating Keller from print to stage or image via the acting of Patty Duke or Hallie Eisenberg. This book, then, will help readers and viewers recognize that adaptation is not neutral and can reinforce or critique disability issues, such as ableism and representation.

Film scholar Robin Wood famously argued that "central to the effect and fascination of horror films is their fulfillment of our nightmare wish to smash the norms that oppress us and which our moral condition teaches us to revere." From the very beginnings of the silent film era to our present day, the horror genre has continued to attract audiences and proliferate across multiple modes of film and media—addressing our fears, anxieties, and sometimes our deepest, darkest fantasies. Amidst the perpetual unease of the 21st century with its ever-present threats of environmental disaster and climate change, viral pandemics, economic recessions, political uprisings, mass shootings, and ongoing warfare it is hardly surprising that the horror genre is more prolific and popular than ever. We are arguably living in the most diverse media ecology ever, especially in terms of medium and genre. However, in the realm of Horror Studies, the tendency to focus on several key literary or cinematic texts or bodies of work by specific authors or directors often excludes works from marginalized voices or from less scrutinized media. We aim to highlight those texts/voices. Consequently, this collection assembles a wide range of scholarship addressing the intersections, influences, and impacts of the horror genre's proliferation across multiple forms of media including film, television, web sites, video games, tabletop and role-playing games, and social media.
